

Bidders must upload self-attested photocopies of valid GST registration Certificate with current challan, last three years Income Tax Return with PAN Card, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License with current challan from local bodies as the case may be.

Bidders must submit Credential in similar nature of work for last 3 years.

- In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.

Failure to execute the contract will lead to automatic cancellation of the bid.
- 12 Quoted rate shall be inclusive of all charges including royalty, tools charges, transportation etc.
- Registerb Partnership Deed in case of partnership firm has to be submitted. The company shall furnish the Article of Association ans Memorandum.
