- Bidders must upload self-attested photocopies of valid GST registration Certificate, last three years Income Tax Return with PAN Card, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License with current challan from local bodies as
- Bidders must submit Credential in similar nature of work (Date of Creadintial must be within last three years from the first date tender
- In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.

- 5. No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders.
- 7. Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) deducted from every running payment (not exceeding three including the Final bill) made and will be released 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases.
- 8. GST, ITDS and Labour Cess will be deducted as per existing rates fixed by the respective department of the Government.
- 9 Site visit may be done by the bidders at their own cost.
- 10. Erroneous or incomplete e-Tender will be summarily rejected without assigning any reason whatsoever.
- 11. Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within three days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
- 12 Quoted rate shall be inclusive of all charges including royalty, tools charges, transportation etc.
- 13. RegisterPartnership Deed in case of partnership firm has to be submitted. The company shall furnish the Article of Association ans Memorandum. Where an individual persion holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual persion shall where uploading any tender for on behalf of the company or firm invariablely upload a copy of register power of attorneyshowing clear authorisation in his favour, by the rest of the director of such com[pany or the partner of such tender.(non statutary document.)
- 14 Joint venture will not be allowed.
- Payment will be made as and when fund is available from the concerned source. No claim for whatsever for R.A. Bill payment. Only final Bill will be paid for this work. Contructors are requested to quote their rate accordingly.
- During security if it comes to notice of the tender inviting authority that the credential or any other paper found incorrect/ manufacture/ fabricated, that bidder would not be allowd to participate in the tender and the application will be rejec without any prejudice.
- 17 The contructor's responsibility to keep the road open to all kind of traffic duribng the execution of work. No claim whats so ever will be entertain for idle labour, establishment cost of hire and labor charges of tools and plants and any unwanted incidance etc. at any circumstances.
- time is the essence of contruct. The successfully contructor must start the work within seven days from the date of signing of agreement/ contruct failing which the undersigned may cancelled the work order and contruct and forfit the earnest money. The work should be completed within the prescribed time. No extention of time will be allowed accepted in special cases if it is found that the delay caused due to such reason which is beyond the controll of the contructur and on the issue wheather any reason is beyond the control of the contructor, the decision of the undersigned shall be final.
- 18 A. A penulty @ of 0.1% (Zero point one percent) of the value of the work may be imposed on per day of delay.
- 18 B. If during execution of work it is found that the progress of work is very slow and the contructor failed to speed up the work even after repeated reminders and the work is going to be delaid unnecessarily due to fault on the part of the contructor and/ or the quality of work is not as per the plan and estimate and the contructor does not make required rectification after being so instructed, the work order and contruct shal; I be cancelled, the earnest money shall be forfitted, the contructor may be black listed and claim of payment of work already executed before such termination, may not be considered or entertained.
- 18 C. In case of such mid-term termination of the work order and contruct at, the undersigned may also proceed to get the bal;ance work completed by engaging other contructos's agencies or departmentaly. The excess expenditure if any, due to such a step would be recoverable from the unpaid bills of the defaulting contructor, if claim of such bills has not been forfitted at the time of termination of work order and contruct as mentioned at point be above.
 - Bidder(s) may be asked to submit further analysis for items where the quated rate are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to belive that the bidder have formed a cartel and rates have been manupulated, unbalanced or unreasonable.
