**Annexure-B  
Terms & Conditions :-**

- Cost of Tender Form (non-refundable) has to be paid in cash only.
- Bidders must submit attested photocopies of valid GST registration Certificate (if any), last three years Income Tax Return, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be.
- Bidders must submit Creditor in similar nature of work during last three years.
- In case of bid tender originating from cancellation of bidder, entire tender process will be voided.
- Bidders must quote rates in absolute numerical values (both in figures and words) and percentage against the estimated cost.
- Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
- No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/Engineering Cooperative etc. In other words, all participating Bidders will be treated in equal basis only and no favourable special considerations will be accorded to any bidder.
- Bidders must submit sealed envelope clearly mentioning serial number and name of work on top of the envelope.
- Earnest money should be deposited in Cash/Cheque/Bank Draft or Government Bond Securities duly pledged in favour of the Panchayat, Anantapur Gram Panchayat and will be refunded forthright as the case may be. In case of cash cheque/bank draft, the bidder must submit money receipt from Gram Panchayat office and quote the number of tender form. In case of Government Bond securities respective pledging documents need to be submitted along-with Sealed Tender.
- Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of Cash/Cheque/Bank Draft/Government Bond - Securities duly pledged in favour of the Panchayat, Anantapur Gram Panchayat or the amount may be deducted from every running payment just exceeding three including the final bill made and will be released 6 months in case of Building, Curved and Concrete Roads and 3 months in all other cases.
- STDS-GST, ITDS and Labour Costs will be deducted as per existing rates fixed by the respective department of the government.
- Pre-bid conference/meeting with the prospective Bidders will be held on 24/01/2020 3 PM that later than 4 days before the last date of submission of Tender. Environmental and Social Safeguards issues pertaining to the tendered work will also be discussed and explained in the meeting.
- Site visit may be done by the bidders at their own cost.

17. Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.
18. Bidder(s) must be asked to submit site analysis for roads which the quoted rates per kilometer or above 5% than the estimated rates. Such bid may also be considered as valid and valid if there is a reason to believe that the Bidder has formed a valid and true basis for his assessment, understanding or interpretation.
19. Sanctioned Bidder will have to execute a formal contract on a Non-Bidder's format paper within seven days from the issuance of "Letter of Acceptance" with the Government wherein the descriptions, specifications, quantity, date of completion of work, other disclaimers conditions and ESMF (Environmental and Social Management Framework) clauses shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
20. The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.
21. Quoted rate shall be exclusive of all charges including HED, CST, local charges, transportation, etc.
22. Any bid received from the bidder without authentication of signature made on site printed or word or Tenders shall lead to cancellation of the bid.
23. Bidders will get necessary meetings with the Tender Form. All documents i.e. drawings Tender Form signed by the Bidder must be submitted in General Tender addressed to Product Manager Gram Panchayat - V.O. - Material , P.O - Mulahe , Dist - Uttar Dinajpur
24. The quoted rates shall be inclusive of GST and Late fee rates but exclusive of all other taxes including any CENVAT credit Levy or tax by whatever name called imposed under GST law or any other law at any time GST at the applicable rates shall be payable areas.
25. Tenderer shall examine the various components of GST Act and Rules (up to date amendments) and other applicable laws before bidding.
26. The contractor shall submit the details of the work executed as per rate. The rates will be calculated as per rates.
27. ITTB, GST, TTB, Other fees and other statutory disbursements shall be made at source as per prevailing laws.
