4. Eligibility criteria for participation in Tender.

- i) The Prospective bidders shall have satisfactorily completed as a prime agency during the last 5 (five) years prior to the date of issue of this Notice at least one work of same/similar nature of work under authority of State/Central Govt., Central/State Government undertaking /Statutory Bodies and Having past credentials (Payment) Certificate 60% (Sixty Percent) of the Estimated amount put to tender.
- ii) Current Bank Solvency Certificate / Bank Guarantee Certificate of the Agency to be Provided within financial year of application at least 40% (Fourty Percent) of tender Amount /Work value (Both Unemployed Engineers Co-operative Societies and Un-employed Labour Co-operative Societies)
- **iii)** Valid P.tax, Trade licence, pan Card, G.ST registration Certificate along with up to date clearance challan, and income tax clearance certificate for the year 2018-19 to be accompanied /scaned with the technical bid documents.
- **iv)** Registered Unemployed Engineers Co- operative Societies /Unemployed Labour Co-operative Societies are required to furnish Current Audit Report, along with other relevant supporting papers.
- v) Joint Ventures will not be allowed.
- **vi)** The Partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum.
- **vii)** Where an Individual person holds a Digital Certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, while uploading any tender for and on behalf of such company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the directors of such company or the partners of such firm, to upload such tender. The power of attorney shall have to be registered in accordance with the provisions of the Registration Act, 1908.
- **viii)** The Tenderer should disclose if there is any pending liable upon of the firm which may have implications on the liquidity of the farm, if they are black-listed by any Govt. Dept. /Semi Govt. /Autonomous bodies/PSUs etc.
