The intending tenderer shall have to submit valid PAN issued by the IT Deptt., Govt. of India, I/Tax(current), Professional Tax(current), valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017 along with satisfactory completed as a prime agency during the last 5 (five) years prior to the date of issue of this Notice at least one work of similar nature under authority of State / Central Govt., State / Central Government undertaking / Statutory Bodies and reputed any other concern and having at least 50% (fifty percent) credential of the estimated amount put to tender. Tax invoice(s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017.

Rate should be quoted in % (Percentage) in respect of project cost. The rate will include all taxes etc.

The tender documents will be opened on 11-03-2020 at 4.00 P.M in presence of tenderers in the Tender Section of Uttar Dinajpur Zilla Parishad.
