The tender documents duly filled in all respect should be dropped in the tender box of this office on or before 3.00 pm (as per office clock) on 27.05.20. Any sealed cover of tender received after the date & time set forth will not be entertained and will be returned unopened. Zilla Parishad does not take any responsibility for any delay.

Earnest money 2% (two percent) on the tender amount in the shape of DD (Demand Draft) / bankers cheque / pay order to be purchased in favour of the Additional Executive Officer, Uttar Dinajpur Zilla Parishad on any Nationalized Bank / scheduled bank to be submitted along with tender documents in a sealed cover.

The intending participants shall have to submit valid PAN, issued by the IT Deptt., Govt. of India, I/Tax (19-20), Professional Tax(19-18), valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act,2017.

Rate should be quoted in % (Percentage) in respect of project cost. The rate will include all taxes etc.

The intending participants will have to apply in their letter head mentioning NIT No. & Date for the job in a sealed cover to submit to the Additional Executive Officer, Uttar Dinajpur Zilla Parishad or deudzp@gmail.com on or before 27.05.20 up to 3.00 P.M. and thereafter it will be opened by the authority to this Zilla Parishad. Participants may remain present at the time of opening of the quotations.

The tender documents will be opened on 27.05.20 at 4.00 pm in presence of participants in the Tender Section of Uttar Dinajpur Zilla Parishad.

The Additional Executive Officer, Uttar Dinajpur Zilla Parishad reserves the right to accept or reject or cancel any or all prequalification documents without assigning any reasons whatsoever and not bound to accept the lowest rate without assigning any reasons thereof.

All duties, taxes royalties' cess (including 1% cess under W.B. Building and other Construction workers Welfare Cess). Regulation of Employments & condition of Service Act, 1996, toll taxes and other levies payable by the contractor under the contract to the State / Central Government for any other cause, shall be included in the rates, prices and total tender price submitted by the tenderer. One percent cess under W.B. Building and other Construction Workers (Regulation of Employments & condition of Service) Welfare cess Act, 1996 will be deducted from the bill(s).

To keep the work in good condition after the completion of the work as per tender clause, if any additional / excess work is required over the stipulated quantity in the schedule for routine maintenance work, the same will be treated as defect liability and the contractor has to do the maintenance work at own cost.
