The tender documents duly filled in all respect should be dropped in the tender box of this office before 3.00 pm (as per office clock) on 22-Jul-20. Any sealed cover of tender recieved after the date & time set forth will not be entertained and will be returned unopened. Zilla Parishad does not take any responsibility for any delay

Earnest money 2% (two percent) on the tender amount in the shape of DD (Demand Draft) / bankers cheque / pay order to be purchased in favour of the Additional Executive Officer, Uttar Dinajpur Zilla Parishad on any Nationalized/ Bank scheduled bank to be submitted along with tender documents in a sealed cover.

The intending tenderer shall have to submit valid PAN issued by the IT Deptt., Govt. of India, I/Tax(current), Professional Tax(current), valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017 along with satisfactory completed as a prime agency during the last 5 (five) years prior to the date of issue of this Notice at least one work of similar nature under authority of State / Central Govt., State / Central Government undertaking / Statutory Bodies and reputed any other concern and having at least 60% (sixty percent) credential of the estimated amount put to tender . Tax invoice(s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017.

Rate should be quoted in % (Percentage) in respect of project cost. The rate will include all taxes etc.

The tender documents will be opened on 22-Jul-20 at 4.00 P.M in presence of tenderers in the Tender Section of Uttar Dinajpur Zilla Parishad.

The Additional Executive Officer, Uttar Dinajpur Zilla Parishad reserves the right to accept or reject or cancel any or all prequalification documents without assigning any reasons whatsoever and not bound to accept the lowest rate without assigning any reasons thereof.

All duties, taxes royalties' cess (including 1% cess under W.B. Building and other Construction workers Welfare Cess). Regulation of Employments condition of Service Act, 1996, toll taxes and other levies payable by the contractor under the contract to the State / Central Government for any other cause, shall be included in the rates, prices and total tender price submitted by the tenderer. One percent cess under W.B. Building and other Construction Workers (Regulation of Employments condition of Service) Welfare cess Act, 1996 will be deducted from the bill(s).

To keep the road / culvert / building in good condition during the next six / twelve months after the completion of the work, if any additional / excess work is required over the stipulated quantity in the schedule for routine maintenance work, the same will be treated as defect liability and the contractor has to do the maintenance work at own cost.

There will be "Defect Liability Period" as stated in bidding documents and the security deposit will be release to the contractor after that.

The OEM authorization letter of tender specified OEM at lease of brands should be included with a technical bid and OEM should have serviced by bidder

OEM authorization /warranty signed either by Area Manager or equivalent category executive

Above all items should be supply with ISI Mark. All Fittings should be made in INDIA (The authority of Zilla Parishad reserved the right to accept or reject any brand without assigning any reason),
The Additional Executive Officer, Uttar Dinajpur Zilla Parishad reserves the right to reject or cancel any or all prequalification documents and tender documents without assigning any reason whatsoever.

Successful agency will have to complete the same within the time stipulated in the work order.


