\* # Tenders, so received within 23.07.2020 up to 3.30 P.M.. will be opened on 23.07.2020 at 4.00 P.M. at the office of the Dhankoil G.P. The intending tenderers / Authorized Persons (must be submit authorization letter) may remain present at the time of opening of the offers.

### Terms & Conditions -

- 01 Cost of Tender Form (non-refundable) has to be paid in cash only.
- 02 In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- 03 Bidders must quote rates in item rate basis ( in figures as well as in words.)
- 04 Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- 05 Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
- 06 No special preferences in Earnest money/Security Deposit will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders .
- 07 All Materials will have to be supplied as per specification at work site as per and as per direction of Nirman Sahayak or any authorized person.
- 08 Earnest money should be deposited in Cash/Cheque/Bank Draft or Government Bond/Securities duly pledged in favour of the Pradhan, Dhankoil Gram Panchayat and will be refunded/forfeited as the case may be. In case of Cash/cheque/bank draft, the bidder must collect receipt from Gram Panchayat office and quote the Number in Tender Form. In case of Government Bond/securities respective pledged documents need to be submitted along-with Sealed Tender.
- 09 Earnest money of Successful Bidder (s) and will be released after completion of supply .
- 10 Applicable Taxes will be deducted as per existing rates fixed by the respective department of the government.
- 11 Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.
- 12 Successful Bidder will have to execute a formal agreement on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
- 13 The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.
- 14 Quoted rate shall be inclusive of all charges including royalty, GST ,cess, tools charges, transportation etc.
- 15 If any Non quality Materials is supplied, the receiving authority has every right to reject it out rightly and will be asked to agency to lift the materials immediately.
- 16 The successful tenderer will have to procure Non-Judicial Stamp paper in his/her own cost.
- 17 CGST & SGST will be deducted from bill (if applicable )
