5. The documents submitted by the bidders should be properly indexed & digitally signed. .
6. The successful bidders will get the bill after getting water testing report.
7. Eligibility criteria for participation in tender:
 - i) a) Intending tenderers should produce credential of a Same/Similar nature of Work of the minimum value of 40% of the estimated amount put to tender during 5(five) years prior to the date of issue of this tender notice ; or,
b) Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 80% or more and value of which is not less than the desired value at (i) above; in case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender, In the required certificate it should be clearly stated that the work in progress satisfactorily and also that no penal action has been initiated against the executed agency i.e. ,the tenderer.
 - iii) Pan Card, Trade license, Professional Tax receipts Challan for the year 2019-20, **Valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act,2017**,Current Income tax Acknowledgement (Saral) receipt to be accompanied with the Technical Bid document.
 - v) Registered Unemployed Engineers' Co-operative Societies/Unemployed Labour Co-operative Societies are required to furnish valid Bye Law, Current Audit Report, and Valid latest Clearance Certificate from A.R.C.S. along with other relevant supporting papers.
 - vi) Joint Ventures will not be allowed.
 - vii) The partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum.
 - viii) Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, while uploading any tender for and on behalf of such company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the directors of such company or the partners of such firm, to upload such tender. The power of attorney shall have to be registered in accordance with the provisions of the Registration Act, 1908.
8. **Constructional Labour Welfare Cess @ 1.00%** of cost of construction will be deducted from every bill of the selected agency, GST, Royalty & all other Statutory levy/Cess will have to be borne by the contractor & the rate in the schedule of rates inclusive of all the taxes & Cess stated above.
9. **No Mobilization Advance and Secured Advance will be allowed.**
10. Agencies shall have to arrange required land for installation of plant & machineries, storing of materials, labour shed, laboratory etc. at their own cost and responsibility nearest to the work site.
