- 4) For participating in the Tender, the Tenderer shall have to pay the Earnest Money (EMD) in the form of Demand Draft, duly pledged in favour of the Pradhan Baruna Gram Panchayat, payable at RCCB Kanur issued by any Nationalized Bank on/ after the date of publication of this Notice, for the amounts mentioned in the Annexure A. Separate EMD and participation charge should be used for each work. The original copies of the Earnest Money should be submitted in sealed envelopes to the undersigned on 28 / 06 / 2020 upto 2:00 PM positively super scribing the name of the Agency/ Supplier/ Company and the name of work they applied for. Scanned copies of the Demand Draft (Self Attested) for towards the EMD should be deposited as Statutory Document/ Technical file. Unable to submit the Original EMD, Participation Charge & Original Copies of All the documents submitted online (Non Statutory Documents) on the stipulated date and time the BID will be summarily be Rejected All bidder should submit EMD and hard copies of all documents will self attested to the tender inviting authority in sealed envelopes to the undersigned.

**Terms & Conditions :-**

1. Cost of Participation Charge (non-refundable) in form of cash/ or directly deposited to the bank and collect the money/receipt from the Gram Panchayat Office and upload the scan copy of the same at the time of submission of the bid.
2. Bidders must upload self-attested photocopies of valid GST registration Certificate, last three years Income Tax Return with PAN Card, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License with current challan from local bodies as the case may be.
3. Bidders must submit Credential in similar nature of work.
4. In case of bidder emanating from canalization of bidders, entire tender process will be cancelled.
5. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
6. No special preference in respect of Earnest Money Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders.
7. Earnest money should be deposited in Demand Draft duly pledged in favour of the Pradhan, Baruna Gram Panchayat payable at RCOB Kurur and will be refunded/offretied as the case may be. In case of Demand draft, the bidder must collect money receipt from Gram Panchayat office.
8. Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) deducted from every running payment (not exceeding three including the Final bill) made and will be released 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases.
9. GST, TDS and Labour Cess will be deducted as per existing rates fixed by the respective department of the Government.
10. Site visit may be done by the bidders at their own cost.
11. Erroneous or incomplete e-Tender will be summarily rejected without assigning any reason whatsoever.
12. Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
