- 1. Cost of Participation Charge (non-refundable). In forms of directly deposited to the Bank/ RTGS/ NEFT having account no 11882677747, SBI, Madanpur Branch IFSC code SBIN0009701 in favour of Pradhan, Bhander Gram Panchayat, Kaliyaganj, Uttar Dinajpur, and self attested scan copy of deposit slip are to be uploaded as proof at the time of submission of bid.
- 2. Bidders must upload self-attested photocopies of valid GST registration Certificate, last three years Income Tax Return with PAN Card, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License with current challan from local bodies as the case may be.
- 3. Bidders must submit Credential in similar nature of work.
- 4. In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- 5. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- 6.
