Incomplete tender will be rejected summarily. The Successful tenderer will have to execute a formal agreement on a Non-stamp worth Rs. 10/- within 10 working days from the date of issue of work order.

The undersigned may also proceed the balance work completed by any other means including through other contractor. The excess expenditure if any due to such delay will be recoverable from the unpaid bills security deposit of tenderer. This is apart from any other penal measure the signed may take, including blacklisting of the contractors and forfeiture of earnest money.
