Terms & Conditions :-

1. Cost of Participation Charge (non-refundable).
2. **Bidders must upload self-attested photocopies of valid GST registration Certificate, last three assessment years Income Tax Return(2020-21) with PAN Card, Profession Tax Registration Certificate with current challan and Trade License for the Financial Year 2020-2021**
3. **Bidders must submit Credential in similar nature of work within last 3 Years financial year**
4. In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
5. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
6. No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders.
7. **Participation charge should be deposited in cash and the bidder must collect money receipt (From V) from Gram Panchayat office and upload the scanned copy and Counter Foil (Subscribing the NIT No, Date and SI No) of the same at the time of submission of bid.**
8. **The original Demand Draft/Cheque against Earnest Money deposit should be submitted by all bidders physically within 15/02/2021 upto 2.00 PM and upload the scanned copy and Counter Foil (Subscribing the NIT No, Date and SI No) of the same at the time of submission of bid.**
9. Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) deducted from every running payment (not exceeding three including the Final bill) made and will be released 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases.
10. GST, ITDS and Labour Cess will be deducted as per existing rates fixed by the respective department of the Government.
11. Site visit may be done by the bidders at their own cost.
12. Erroneous or incomplete e-Tender will be summarily rejected without assigning any reason whatsoever.

Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed.
