- 0. Earnest money should be deposited in Bank Draft only duly pledged in favour of The Pradhan, Bhatun Gram Panchayat and w語 be efunded/forfeited as the case may be. In case of bank draft, the bidder must collect receipt from Gram Panchayat office and quote the former in Tender
- 11. Successful Bidder (s) will be required to lodge security deposit (10 % of the total value of the work as quoted by him) as performance security in the form of Cash/Cheque/Bank Draft/Government Bond / Securities duly pledged in favour of the Pradhan, Bhatun Gram Panchayat OR the amount may be deducted from every running payment (not exceeding two including the final bill made .
- 11.a. The DLP (Defects liability Period) period is 5 (Five) years in case New Building/Rigid Pavement/Culvert/Flexible pavement covered by Mastic work and 30% of the SD shall be refunded after expiry of 4(four) years and rest 70% shall be refunded after expiry of 5(five) years.
- 11.b. In case of Flexible Pavement/Extension of Building/Culvert/bridge the DLP period is 3 (three) years and 30% of the SD shall be refunded after expiry of 2(Two) years and rest 70% shall be refunded after expiry of 3(Three) years.
- 11.c. In case of through Bituminous surfacing repair work less than 40 mm thick./Repair of any road/Building/Culvert/bridge/sanitary Epiantics work the DLP period is 1 (One) years and 100% of the SD shall be refunded after expiry of 1(one) year
- 11.d. In case of patch repair or patch maintenance DLP period is 3(three) months from date completion of work and 100% of the SD shall be refunded after expiry of 3(Three) months.
- 12. STDS, ITDS and Labour Cess, GSTwill be deducted as per existing rates fixed by the respective department of the government.
- 13. Site visit may be done by the bidders at their own cost.
- 14. Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.
- 15. Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either below or above 5% than the estimated cost.
