Bidders must submit attested photocopies of valid GST registration certificate, Profession Tax Registration Certificate with current challan attached as the case may be.

Bidders must submit Credential in similar nature of work during last 3 years. In case of bid/tender emanating from cartelization of bidders, entire bid shall be rejected.

Bidders must quote rates in absolute numerical values (both bid and estimated cost).

Rate offered by a bidder in a particular Tender shall be treated as final. Any change in price shall not be allowed.

Multiple bids (more than one bid by same bidder) and variable bids shall be rejected outright.

No special preferences in respect of Earnest Money, Security Deposit, Government owned Company/Government Undertaking/Cooperative Societies Participating Bidders will be treated on equal basis only and no favouritism shall be shown.
