(1) Profession Tax Registration Certificate (Certificate of Enrollment) three (3) years Income Tax Return (Acnowledgement Form-5) (6) Trade Registration Certificate/License from local bodies (valid for Cheque)[original DCR/Demand Draft/Bankers Cheque against Earnest Money Deposit (EMD) should be submitted all Bidder physically with in 02/08/2021 up to 3.00 PM.] (9) Participation Charge to be submitted by Cash in any working day upto 30/07/2021 (from 11.00 Engineers' Co-operative Societies/Unemployed Labour Co-operative Societies are required to furnish valid Bye Law, & Valid Clearance Certificate from A.R.C.S. for the year 2020 along with other relevant supporting papers etc.

Terms & Conditions : -

- 1. The Participation Charge to be submitted by Cash in any working day upto 30/07/2021 (from 11.00 AM to 3.00 PM) at GP Office and also receipt copy (Matfarakka) to be documented through e-filling (non-refundable).
- 2. Bidders must up-loadd the clear scan copy of PAN Card, Valid 15 digit GST Identification Number, last three years Income Tax Return, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be.
- 3. Bidders must up-load Credential in similar nature of work during last three years.
- 4. In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- 5. Bidders must quote rates in percentage (less/Above) basis against the estimated cost and must fill Bidders name in BOQ
- 6. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- 7. The prospective bidders shall have in their full time engagement experienced technical personnel, with the sufficient knowledge of PERT/CPM, the minimum being one Civil Engineer of Diploma holder (Authenticated documents in respect of qualification and engagement shall be furnished for Technical Evaluation).(It is applicable for the tender/Work valu above 8 lakh)
- 8. No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders.
- 9. The original Demand Draft /DCR against Earnest Money Deposit (EMD) should be submitted all biders physically with in 02/08/21 up to 3.00 PM.
- 10. Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of Cheque/Bank Draft/Securities duly pledged in favour of the Pradhan, Dhankoil Gram Panchayat or the amount may be deducted from every running payment (not exceeding three including the final bill) made and will be released 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases.
- 11. I.T, SGST, CGST and Labour Cess will be deducted as per existing rates fixed by the respective department of the government.
- 12. Site visit may be done by the bidders at their own cost.

Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.

Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
