

3. The intending bidders are advised to take Money receipt of Earnest money and Participation fee showing their bank copy to the office and same should upload at the time of e Filling.

4. Those bidders have collected Miscellaneous receipt For EMD as well as Participation fees can utilize Participation receipt for this eNIT abiding WB Tender rules.

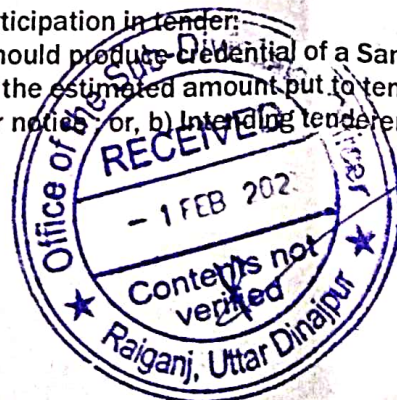
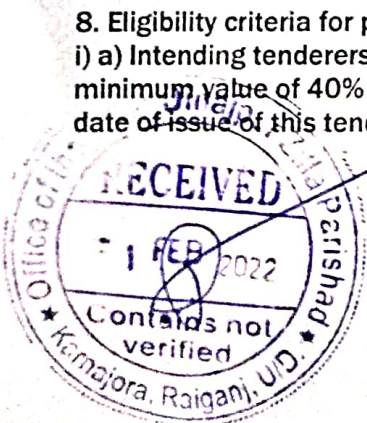
5. Those bidder who will not upload EMD as well as PP receipt , their bid will be rejected .

6. The L1 bidder should be submitted physically the hard copy of the documents (original Demand Draft/RTGS/Transfer money receipt against Earnest money and Participation fees receipt) to the office of the undersigned with his acceptance letter of the L-1 within 3 (three) days from the letter of acceptance.

7. Failure to submit the hard copy with the acceptance letter may be construed as an attempt to disturb the tendering process and action will be taken as per law and same should be documented through e-filling .The documents submitted by the bidders should be properly indexed & digitally signed. .

8. Eligibility criteria for participation in tender:

i) a) Intending tenderers should produce ~~Document~~ of a Same/Similar nature of Work of the minimum value of 40% of the estimated amount put to tender during 5 (five) years prior to the date of issue of this tender notice or, b) Intending tenderers should produce credential of (two)



Same/Similar nature of Work of the minimum value of 30% of the estimated amount put to tender during 5 (five) years prior to the date of issue of this tender notice ; or , c) Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 80% or more and value of which is not less than the desired value at (i) above; in case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender, In the required certificate it should be clearly stated that the work in progress satisfactorily and also that no penal action has been initiated against the executed agency i.e. ,the tenderer.

ii) Each bidder should have achieved a minimum financial turnover (60% of amount put to tender in any one year during the last five years in the same name and style (Certified by Chartered accountant) and at least 50% of which is from Civil Engineering works.

iii) Pan Card, Trade license, Professional Tax receipts Challan for the year 2021-22, Valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act,2017 , Three Years (2019-20, 2020-21, 2021-22) Income tax Acknowledgement (Sara) receipt to be accompanied with the Technical Bid document.

iv) Registered Unemployed Engineers' Co-operative Societies/Unemployed Labour Co-operative Societies are required to furnish alid Bye Law, Current Audit Report, and Valid latest Clearance Certificate from A.R.C.S. along with other relevant supporting Papers.

v) Joint Ventures will not be allowed.

vi) The partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum.

vii) Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, while uploading any tender for and on behalf of such company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the directors of such company or the partners of such firm, to upload such tender. The power of attorney shall have to be registered in accordance with the provisions of the Registration Act, 1908.

9. Constructional Labour Welfare Cess @ 1.00% of cost of construction will be deducted from every bill of the selected agency, GST, Royalty & all other Statutory levy/Cess will have to be borne by the contractor & the rate in the schedule of rates inclusive of all the taxes & Cess stated above.

10. No Mobilization Advance and Secured Advance will be allowed.

11. Agencies shall have to arrange required land for installation of plant & machineries, storing of materials, labour shed, laboratory etc. at their own cost and responsibility nearest to the work site.

12.a. The DLP (Defects liability Period) period is 5 (Five) years in case New Building/Rigid Pavement/Culvert/Flexible pavement covered by Mastic work and 30% of the SD shall be refunded after expiry of 4(four) years and rest 70% shall be refunded after expiry of 5(five) years.

b. In case of Flexible Pavement/Extension of Building/Culvert/bridge the DLP period is 3 (three) years and 30% of the SD shall be refunded after expiry of 2(Two) years and rest 70% shall be refunded after expiry of 3(Three) years.

c. In case of through Bituminous surfacing repair work less than 40 mm thick./Repair of any road/Building/Culvert/bridge/sanitary & plumbing work the DLP period is 1 (One) years and 100% of the SD shall be refunded after expiry of 1(one) year.

d. In case of patch repair or patch maintenance DLP period is 3(three) months from date completion of work and 100% of the SD shall be refunded after expiry of 3(Three) months .

- Experience

The eligibility of a bidder will be ascertained on the basis of the self attested documents in support of the minimum criteria as mentioned a, b, c above and the declaration executed through prescribed affidavit (Format attached) in non-judicial stamp paper of appropriate value duly notarized. If any document submitted by a bidder is either manufactured or false, in such cases the eligibility of the bidder/tenderer will be out rightly rejected at any state without any prejudice with forfeiture of earnest money forthwith The Pradhan , Bhatun Gram Panchayat, P.O.-Bhatol Hat, P.S.- Raiganj , Dist;- Uttar Dinajpur reserves the right to reject or cancel any or all prequalification documents and tender documents without assigning any reason whatsoever.
