- 2) In the event of filing intending bidder may be get the tender document from the Gram Panchayat Office directly.
- 3) Both Technical Bid and Financial Bid will be submitted at Gram Panchayat Office in Office time.
- 4) The financial offer of the prospective tenderer will be considered only if the tender qualifies in the Technical Bid and the tenderer is found eligible by the Tender Inviting Authority. The list of qualified tenderers will be displayed in the website on the schedule date and time.
- 5) For participating in the Tender, the Tenderer shall have to pay the participation charge in form of cash and collect money receipt from the Gram panchayat office and submitted zerox copy of the same at the time of submission of bid and the Earnest Money (EMD) in the form of Demand Draft or Cash duly pledged in favour of the Pradhan Joyhat Gram Panchayat payable at BGVB, Baidara Branch, issued by any Nationalized Bank on / after the date of publication of this Notice, for the amounts mentioned in the Annexure -A. Separate EMD and participation charge should be used for each work.

Annexure-B

1. Cost of Participation Charge (non-refundable).
2. Bidders must upload self-attested photocopies of valid GST registration Certificate, last three years Income Tax Return with PAN Card, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License with current challan from local bodies as the case may be.
3. Bidders must submit Credential in similar nature of work.
4. In case of bidder emanating from cartelization of bidders, entire tender process will be cancelled.
5. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
6. No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders.

7. Earnest money should be deposited in Demand Draft duly pledged in favour of the Pradhan, JOYHAT Gram Panchayat payable at BGVB, Baldara Branch and will be refunded/forfeited as the case may be. In case of Demand draft, the bidder must collect money receipt from Gram Panchayat office.
8. Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) deducted from every running payment (not exceeding three including the Final bill) made and will be released 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases.
9. GST, ITDS and Labour Cess will be deducted as per existing rates fixed by the respective department of the Government
10. Site visit may be done by the bidders at their own cost.
11. Erroneous or incomplete e-Tender will be summarily rejected without assigning any reason whatsoever.
12. Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of 'Letter of Acceptance' with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
13. The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason
14. Quoted rate shall be inclusive of all charges including royalty, GST, local charges, transportation etc.
