- 4) The financial offer of the prospective tenderer will be considered only if the tender qualifies in the Technical Bid and the tenderer is found eligible by the Tender Inviting Authority. The list of qualified tenderers will be displayed in the website on the schedule date and time.
- 5) For participating in the Tender, the Tenderer shall have to pay the Earnest Money (EMD) in the form of Demand Draft duly pledged in favour of the Pradhan, Bahin Gram Panchayat payable at Raiganj, issued by any Nationalized Bank on or NEFT to the to bank account no 0335010093459 IFSC code PUNB0033520 Punjub National Bank Raiganj branch after the date of publication of this Notice, for the amounts mentioned in the Annexure -A. Scanned copies of the Demand Draft (Self Attested) for towards the EMD should be uploaded as Statutory Document/ Technical File. Unable to submit the Original EMD, Participation Charge & Original Copies of All the documents submitted online (Non Statutory Documents) on the stipulated date and time the BID will be summarily be Rejected. All bidder should submit EMD and hard copies of all documents with self attested to the tender inviting authority in sealed envelopes to the undersigned within 2 (Two) working days from the opening of financial bid.

Terms & Conditions :-

Annexure-B

1. Cost of Participation Charge (non-refundable) has to be deposited to bank account no 0335010093459 IFSC code PUNB0033520 Punjab National Bank Raiganj and upload the scan copy of the deposit slip at the time of submission of the bid and collect money receipt from the Gram Panchayat Office.
2. **Bidders must upload self-attested photocopies of valid GST registration Certificate, last three years Income Tax Return with PAN Card, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License with current challan from local bodies as the case may be.**
3. Bidders must submit Credential in similar nature of work.
4. In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
5. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
6. No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders.
7. **Earnest money should be deposited to bank or NEFT/RTGS to the to bank account no 0335010093459 IFSC code PUNB0033520 Punjab National Bank Raiganj Branch and collect money receipt or Demand Draft duly pledged in favour of the Pradhan, Bahin Gram Panchayat payable at Raiganj and will be refunded/forfeited as the case may be. The bidder must collect money receipt from Gram Panchayat office.**
8. Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) deducted from every running payment (not exceeding three including the Final bill) made and will be released 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases.
9. GST, ITDS and Labour Cess will be deducted as per existing rates fixed by the respective department of the Government.
10. Site visit may be done by the bidders at their own cost.
11. Erroneous or incomplete e-Tender will be summarily rejected without assigning any reason whatsoever.
12. Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within three days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
13. Quoted rate shall be inclusive of all charges including royalty, tools charges, transportation etc.
14. Register/Partnership Deed in case of partnership firm has to be submitted. The company shall furnish the Article of Association and Memorandum. Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall where uploading any tender for on behalf of the company or firm invariably upload a copy of register power of attorney/showing clear authorisation in his favour, by the rest of the director of such company or the partner of such firm to upload such tender. (non statutory document.)
15. Joint venture will not be allowed.
16. Payment will be made as and when fund is available from the concerned source. No claim for whatsoever for R.A. Bill payment. Only final Bill will be paid for this work. Contractors are requested to quote their rate accordingly.
17. During security if it comes to notice of the tender inviting authority that the credential or any other paper found incorrect/ manufacture/ fabricated, that bidder would not be allowed to participate in the tender and the application will be reject without any prejudice.
18. The contractor's responsibility to keep the road open to all kind of traffic during the execution of work. No claim whatso ever will be entertain for idle labour, establishment cost of hire and labor charges of tools and plants and any unwanted incidence etc. at any circumstances.
19. time is the essence of contract. The successfully contractor must start the work within seven days from the date of signing of agreement/ contract falling which the undersigned may cancelled the work order and contract and forfeit the earnest money. The work should be completed within the prescribed time. No extension of time will be allowed accepted in special cases if it is found that the delay caused due to such reason which is beyond the control of the contractor and on the issue wheather any reason is beyond the control of the contractor, the decision of the undersigned shall be final.
- 19 A. A penalty @ of 0.1% (Zero point one percent) of the value of the work may be imposed on per day of delay.
- 19 B. If during execution of work it is found that the progress of work is very slow and the contractor failed to speed up the work even after repeated reminders and the work is going to be delaid unnecessarily due to fault on the part of the contractor and/ or the quality of work is not as per the plan and estimate and the contractor does not make required rectification after being so instructed, the work order and contract shall be cancelled, the earnest money shall be forfeited, the contractor may be black listed and claim of payment of work already executed before such termination, may not be considered or entertained.
- 19 C. In case of such mid-term termination of the work order and contract at, the undersigned may also proceed to get the balance work completed by engaging other contractor's agencies or departmentally. The excess expenditure if any, due to such a step would be recoverable from the unpaid bills of the defaulting contractor, if claim of such bills has not been forfeited at the time of termination of work order and contract as mentioned at point be above.

- 20 Bidder(s) may be asked to submit rate analysis for items where the quoted rate are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the bidder have formed a cartel and rates have been manipulated, unbalanced or unreasonable.
- 21 Agency submit test report of materials if required:- A) Compressive strength of cement B) Grading of sand (sieveanalysis), C) Crushing strength of stone chips.
22. **The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.**
