- Bidders must submit self-attested photocopies of PAN Card, Trade Registration Certificate/License from local bodies as the case may be, Profession Tax Enrollment Certificate's current e-challan i.e(2022-2023), valid GST registration Certificate, last three years income Tax Return i.e (A.Y 2020-2021, 2021-2022 & 2022-2023). Sealed Qualation Paper(s) will be received at this G.P. Office from 12.00 pm to 2.00 pm on 12/11/2021. The same will be open from 2.30 pm on the same date.
- In case of bid/quatation emanating from cartelization of bidders, entire quatation process will be cancelled.
- Rate offered by a bidder in a particular quatation shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- GST, ITDS and Labour Cess will be deducted as per existing rates fixed by the respective department of the Government.
- Site visit may be done by the bidders at their own cost.
- Erroneous or incomplete e-quatation will be summarily rejected without assigning any reason whatsoever
- Quoted rate shall be inclusive of all charges including taxes, royalty, tools charges, transportation etc complete in all respect.
- Registered Partnership Deed in case of partnership firm has to be submitted. The company shall furnish the Article of Association and Memorandum. Where an individual persion holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual persion shall where submitting any qualation for on behalf of the company or firm invariablely submit a copy of registered power of attorney showing clear authorisation in his favour, by the rest of the director of such company or the partner of such firm to submit such qualation.(non statutary document.)
- Joint venture will not be allowed.
- 10 Payment will be made as and when fund is available from the concerned source after fully completion of work. No claim for R.A. Bill payment will be entertained. Only final Bill will be paid for this work. Contractors are requested to quote their rate accordingly.
- The contractor's responsibility is to keep the road open to all kind of traffic during the execution of work. No claim whatsoever will be entertain for idle labour, establishment cost, hire and labor charges of tools and plants and any unwanted incidence etc. at any circumstances
- 12 Time is the essence of contract. The successful contractor must start the work within seven days from the date of signing of agreement/ contract, failing which the undersigned may cancel the work order and contract and forfit the earnest money. The work should be completed within the prescribed time.
