Professional Tax (PT) deposit receipt challan for the current financial year, PAN Card, last 3 years IT return, 15- digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act 2017 (Amendment of Rule 47(9)(b) of WBFR, Vol-I vide memo no 4374-F(Y) dated 13.07.2017 of Finance Department (Audit Branch), Govt of West Bengal) and latest challan.
18. Cess @ 1% (One Percent) of the cost of construction works will be deducted from the bills of the contractors on all contracts awarded on or after 01.11.2006 in persuasion with G.O. No. 599A/4M-28/06 dated 27.09.2006. Deduction of I. Tax should be made as per rule in vogue.

- ii. Registered Deed of partnership Firm and Power of Attorney.
- iii. Valid Trade License from the respective Municipality/Panchayat etc.
