3. The documents submitted by the bidders should be properly indexed & digitally signed.

4. Eligibility criteria for participation in tender:

- i) a) Intending tenderers should produce credential of a Same/Similar nature of Work of the minimum value of 60% of the estimated amount put to tender during 3(Three) years prior to the date of issue of this tender notice, or,
- ii) Each bidder should have achieved a minimum financial turnover (60% of amount put to tender in any one year during the last three (3) years in the same name and style (Certified by Chartered accountant) and at least 60% of which is from Civil Engineering works.
- iii) GST, Pan Card, Trade license, Professional Tax receipts with current e-Challan for the year of 2022-23, Professional Tax Payment Certificate, income tax Acknowledgement receipt of last 3 years to be accompanied with the Technical Bid document.
- iv) Registered Unemployed Engineers' Co-operative Societies/Unemployed Labour Co-operative

- v) Joint Ventures will not be allowed.
- vi) The partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum.
- vii) Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, while uploading any tender for and on behalf of such company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the directors of such company or the partners of such firm, to upload such tender. The power of attorney shall have to be registered in accordance with the provisions of the Registration Act, 1908.
- viii) Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of Cash/Cheque/Bank Draft/Government Bond / Securities duly pledged in favour of the Pradhan, Lahutara-II Gram Panchayat or the amount may be deducted from every running payment (not exceeding three including the in a bill) made and will be released 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases.
- ix) Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.
- x) Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat where in the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.

5. Constructional Labour Welfare Cess@ 1.00% of cost of construction will be deducted from every bill of the selected agency. Royalty & all other Statutory levy/Cess will have to be borne by the contractor & the rate in the schedule of rates inclusive of all the taxes & Cess stated above.

6. No Mobilization Advance and Secured Advance will be allowed.

7. Agencies shall have to arrange required land for installation of plant & machineries, storing of materials, labourshed, laboratory etc. at their own cost and responsibility nearest to the work site.


