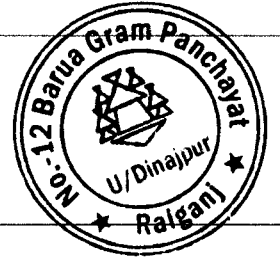

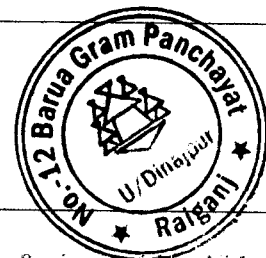

4. The bidder will have to show or submit original testimonials within schedule date & time, either bid will be treated as technically rejected.
3. Eligibility criteria for participation in tender:
- i) a) Intending tenderers should produce credential of a Same/Similar nature of Work of the minimum value of 60% of the estimated amount put to tender during 3(Three) years prior to the date of issue of this tender notice. or,
  - ii) Each bidder should have achieved a minimum financial turnover (60% of amount put to tender in any one year during the last five years in the same name and style (Certified by Chartered accountant) and at least 50% of which is from Civil Engineering works.
  - iii) GST, Pan Card, Trade license, Professional Tax receipts with current e-Challan for the year of 2022-23, Professional Tax Payment Certificate, Income tax Acknowledgement receipt of last 3 years to be accompanied with the Technical Bid document.
  - iv) Registered Unemployed Engineers' Co-operative Societies/Unemployed Labour Co-operative Societies are required to furnish valid Bye Law, Current Audit Report, and Valid latest Clearance Certificate from A.R.C.S. along with other relevant supporting papers.
  - v) Joint Ventures will not be allowed.
  - vi) The partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum.
  - vii) Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, while uploading any tender for and on behalf of such company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the directors of such company or the partners of such firm, to upload such tender.
