- forms & Conditions : deers must upload self-attested photocopies of valid GST registration Certificate with Current Return, last three years Income Tax Return with PAN Card (Assessment Year 2020-21, 2021-22 and 2022-23), Profession Tax Registration Certificate with current challan(2022-23) and Trade Registration Certificate/License(2022-23).
 - Bidders must submit Credential in similar nature of work inbetween the last three financial years (i.e. 2019-20, 2020-21 and 2021-22)
 - In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled
