- The financial offer of the prospective tenderer will be considered only if the tender qualifies in the Technical Bid and the tenderer is found eligible by the Tender Inviting Authority. The list of qualified tenderers will be displayed in the website on the schedule date and time.
- For participating in the Tender, the Tenderer shall have to pay the Earnest Money(EMD) in the form of Online mode only NEFT/RTGS in favour of Own Fund account of Sitgram Gram Panchayat A/C Name: PRODHAN 7NO SITGRAM GRAM PPANCHAYAT, A/C NO 5416010006878, BANGIYA GRAMIN VIKASH BANK, PANISAL BRANCH, IFSC: PUNBORRBBGB, for the amounts mentioned in the Annexure A Separate EMD should be used for each work. - 7 Bidders must submit Credential in similar nature of work.
- 8 In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.

- 21 The contructor's responsibility to keep the road open to all kind of traffic duribng the execution of work. No claim whats so ever will be entertain for idle labour, establishment cost of hire and labor charges of tools and plants and any unwanted incidance etc. at any circumstances.
- Time is the essence of contruct.
