- 1 Cost of Participation Charge (non-refundable) directlt deposited/ NEFT/ RTGS to Acount No. 5103010003448 of BGVB, Bindole Branch, IFSC Code PUNB0RRBBGB in favor of Prodhan Bindole GP.
- 2 Bidders must upload self-attested photocopies of valid GST registration Certificate, last three years Income Tax Return with PAN Card, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/ License with current challan from local bodies as the case may be.
- 3 Bidders must submit Credential in same nature of work only. Submession and upload of Spare or improper Credential / documents by the Bidder treated as impediment to development work progress and his participation will be reject without any prejudice.
- 4 In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- 5 Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
