- 4. Eligibility criteria for participation in tender:

a) Credential with self attested: Bonafied resourceful Contractor / Outsider who have Satisfactorily completed as a prime agency during the last 3 (three) years from the date of issue of this N.I.T at least one work of similar nature under authority of State/Central Government, State/Central Government undertaking, Statutory Bodies Constituted under the statute of the Central/State Government at least in the magnitude of 60% (Sixty percent) of the amount put to tender.

- b) Self attested (i) PAN Card, (ii) WITH LAST 3(THREE) YEARS INCOME TAX RETURN (iii) TRADE REGISTRATION CERTIFICATE /LISENCE FROM LOCAL BODY, (iv) Valid GST Registration Certificate with up to date Challan (v) PROFESSIONAL TAX REGISTEATION CERTIFICATE WITH CURRENT CHALLAN/ acknowledgement receipt. vi) Current year Bank Solvency certificate with amount of 60 % of estimated cost mentioned in NIT vii) PF registration certificate & Up to date challan.

- 5. There shall be no provision of Arbitration. Hence Clause 25 of. 2911 (ii) is hereby omitted
- 6. Constructional GST, Royalty & all other statutory levy / Cess will have to be borne by the contractor & the rate in the schedule of rates inclusive of all the taxes & cess stated above.
- 7. Bids shall remain valid for a period of 120 (One hundred and twenty) days after the dead line date for Financial Bid/ Sealed Bid submission. Bid valid for a shorter period shall be rejected by the undersigned as non- responsive.

- 9. Earnest Money: The amount of Earnest Money is 2% (Two percent) or Rs. 20,000/- which ever is less of the estimated amount put to tender through online in favour of Prodhan, Lahutara-II Gram Panchayat, payable at against the work as required. This clause is also applicable for all categories of applicants except those are exempted as per Government Order no.1110-F, Dated-10.02.2006 of Special Secretary Finance Department, Govt. of West Bengal."
- 10. The Bidder, at the Bidder's own responsibility and risk is encouraged to visit and examine the site of works and its Surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice inviting Tender, the cost of visiting the site shall be at the Bidder's own expense.
- 11. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The undersigned reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have incurred by any Bidder at the stage of Bidding.
- 12. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in "Instructions to Bidders" before bidding.
- 13. (i) According to Finance Department, Audit Branch, Govt. of West Bengal vide Oder No. 4608-F(Y), Dated:- 18th July, 2018. In tender for Government works, bids are sometimes received at much lower rate than the estimated amount put to tender. In such cases, to ensure the quality and proper execution of the work in public interest, the Governor is pleased to decide that Additional Performance Security @10% of the Tendered amount shall be obtained from the successful Bidder if the accepted Bid value is 80% or less of the estimate put to tender. (ii) The Additional Performance Security shall be submitted in the form of Bank Guarantee from any scheduled Bank before issuance of the Work Order. If the Bidder fails to submit the Additional Performance Security within seven working days from the date of issuance of Letter of Acceptance, his Earnest Money will be forfeited and other necessary actions as per NIT like blacklisting of the Contractor, etc, may be taken. The Bank Guarantee shall have to be valid upto end of the Contract Period and shall be renewed accordingly, if required. (iii) the Bank Guarantee shall be returned immediately on successful completion of the Contract. If the Bidder fails to complete the work successfully, the Additional

Performance Security shall be forfeited at any time during the pendency of the contract period after serving proper notice to the contractor. - 14. 10 % (ten percent) from every bill will be deducted as security deposit. Same will be refunded as by order of the Governor, West Bengal vide order no. 177-CRC/2M-57/2008, Dated: 12/07/2012 & Group-I of Finance (Audit) Department vide their U.O. No. 614, Dated: 06/07/2012 from actual date of completion of the work if no defect is detected within security period. If any defect is found SD money will not be refunded within the security period.
- 15. As per order of District Magistrate, Uttar Dinajpur vide order No. 114/MA&ME, Dated: 03/02/2016 following deduction was considered as an proper to impose penalty for the delay in completing the respective work. Upto six months-1%, above six months to one year-2%, above one year to two years-4%, above two years to three years-6%, above three years-8%.

IN CASE OF OTHERS WORKS.

- 16. In case of Ascertaining Authority at any stage of application or execution of work necessary registered power of Attorney is to be produced.
- 17. NO CONDITIONAL / INCOMPLETE TENDER will be accepted under any circumstances.
- 18. The undersigned reserves the right to cancel the N.I.T. due to unavoidable Circumstances and no claim in this respect will be entertained.
- 19. During tender processing or when the work in progress, if it comes to the notice to Tender Inviting Authority that the credential or any other papers found incorrect / manufactured / fabricated, that tender will be rejected without any prejudice and necessary action will be taken as per law.
- 20. Before issuance of the work order, the Tender Inviting Authority may verify the credential & other documents of the lowest tenderer if found necessary. After verification, if it is found that such documents submitted by the lowest tenderer is either manufacturer or false in that case, work order will not be issued in favour of the tenderer under any circumstances & E.M.D will stand forfeited at any stage without any reference to the bidder.
- 21. If any discrepancy arises between two similar clauses on different notifications, the clause as stated in later.

- 22. Award of Contact will be issued to the successful bidder from this office. Work Order will be issued by the Prodhan, Lahutara-II Gram Panchayat, and payment will be made by the Gram Panchayat through online according to E-Gram Swaraj system and 15th FC guideline.
- 23. Participation Charge @ Rs. 250.00 upto Rs. 2 lakh, @ Rs. 500.00 from Rs. 2 lakh to Rs. 5 lakh and @ Rs. 750.00 above Rs. 5 lakh of Estimatted Cost should be applicable for all bidders. The Participation Charge also be deposited above mentioned A/C through NEFT/RTGS and the said counter foil should be scan and uploaded in e-filling folder.
- 24. Each bidder should have achieved a minimum financial turnover (60% of amount put to tender in any one year during the last three (3) years in the same name and style (Certified by Chartered accountant) and at least 60% of which is from Civil Engineering works.
- 25. Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.

Each contractor is required to obtain an e-Token for submission of tenders, from the approved service provider of the National Information's Centre(NIC) on payment of requisite amount details are available at the Web Site stated in Clause 2 of Guideline to Tenderer as a USB e-Token.

A. Affidavit

Conditional / incomplete tender will not be allowed.

On that affidavit it should be clearly declared that the agency shall complete the work in all aspects as desired by the Authority. Failure to conduct the works as per specific time and directions will be liable for penal action. On such cases, authority has the right to engage any other agency / agencies without any intimation.

B. Financial proposal

- i. The Financial proposal should contain the following documents in one cover (folder) i.e. Bill of quantities (BOQ) the contractor is to quote the rate Precentage(%) basis online through computer in the space marked for quoting rate in the BOQ.

Penalty for suppression / distortion of facts

If any tenderer fails to produce the original hard copies of any documents on demand of the Tender Inviting Authority i.e. undersigned within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies or if there is any suppression of documents, the tenderer will be suspended from participating in the tenders on e-Tender platform for a 3 (Three) years. In addition, his user ID will be deactivated and Earnest Money Deposit will stand forfeited. Besides, the Department may take appropriate legal action against such defaulting tenderer.

The Tender Inviting Authority i.e. undersigned reserve the right to accept or reject any Bid or cancel Bidding processes and reject all Bids at any time prior to the award of Contract without assigning any reason thereof.
