8. The bids for the work shall remain valid for acceptance for a period not less than 180 (One eighty) Days after the Opening of Financial Bid. The bidders shall have to furnish a declaration executed through prescribed affidavit in non-judicial stamp paper of appropriate value duly notarized.

9. Bidders may bid for any one or more of the works mentioned in the Table above. Central/State Government undertaking/Statutory Bodies and having 60 (sixty) percent of the estimated amount put to tender. Estimated amount, Tendered Amount, Actual date of completion of the project and detail address for communication must be indicated in the Credential Certificate.

Credential: Scanned copy of work credential issued in favour of the contractor/bidder as detailed below:

In case of execution of supplementary/substitute supplementary items having values more than 30% of BOQ, final gross value of bill (without contractual rates) including such supplementary/ substitute supplementary items may be considered to ascertain similarity in nature of work and authenticated copy of such bills may be uploaded, if made available and desired by the bidder.
