- 1 Cost of participation charge (non refundable) as mentioned in ANNEXURE-A is to be submitted in favour of the "Prodhhan, No. 3 Mahipur Gram Panchayat" payable at Bangiya Gramin Vikash Bank, Maharaja Branch, Maharaja, Uttar Dinajpur, West Bengal, A/C no : 5337010000386, IFSC PUNB0RRBBGB by NEFT/RTGS. Scanned copies of deposit slip/online payment receipt on the same should be uploaded as statutory document/Technical file ; failing which the application will be rejected.
- 2 In the event of e-Filing, Earnest Money has to be deposited by the bidder as mentioned in ANNEXURE-A is to be submitted in favour of the "Prodhhan, No. 3 Mahipur Gram Panchayat" payable at Bangiya Gramin Vikash Bank, Maharaja Branch, Maharaja, Uttar Dinajpur, West Bengal, A/C no : 5337010000386, IFSC PUNB0RRBBGB by NEFT/RTGS. Scanned copies of deposit slip/online payment receipt on the same should be uploaded as statutory document/Technical file; No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders. Without EMD, bidder's tender will be treated as informal and will be rejected. Joint venture will not be allowed.
- 3 Bidders must upload self-attested photocopies of valid GST registration Certificate, last three years Income Tax Return with PAN Card, Profession Tax Enrollment Certificate with current e challan (2023-24) and Trade Registration Certificate/License with current challan from local bodies as the case may be.
- 4 Bidders must submit Credential in similar nature of work during last three years as mentioned in Annexure-A.
- 5 In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- 6 Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- 7 Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) which will be deducted from the final bill made and will be released 5 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases.
- 8 GST, ITDS and Labour Cess will be deducted as per existing rates fixed by the respective department of the Government.
- 9 Site visit may be done by the bidders at their own cost.
- 10 Erroneous or incomplete e-Tender will be summarily rejected without assigning any reason whatsoever.
- 11 Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.

Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.

12 Quoted rate shall be inclusive of all charges including royalty, GST, tools charges, transportation etc.

13 Registered Partnership Deed in case of partnership firm has to be submitted. The Company shall furnish the Article of Association and Memorandum, where an individual person holds a DSC in his own name duly issued to him against the company or the firm of which he has happened to be a director or partner, such individual person shall where uploading any tender for on behalf of the company or firm invariably upload a copy of register power of attorney showing clear authorisation in his favour, by the rest of the director of such company or the partner of such firm to upload such tender (non statutory document).

14 If required, the undersigned can verified the attached documents with the originals & the tenderer will be bound to produce the originals during opening of tender on being asked failing which application of tender Tender Forms will be cancelled During scrutiny if it is come to notice of the tender committee that the credential or any other paper found incorrect/manufactured/fabricated that bidder would not be allowed to participate in the tender & the application will be reject without any prejudice.

15 Time is the big essence of the contract. The successful contractor must start the work within 7 (Seven) Days from the date of signing agreement, failing which the undersigned may cancelled the work order contract and forfeited the earnest money. The successful contractor must complete the work within time specified for the completion. No extension of the time will be allowed except on special case. If any contractor fails to complete the work within the stipulated time the work order issued in his favour may be cancelled without assigning any reason thereof. The undersigned may also proceed to get the balance work completed by any other means including through other contractors. The excess expenditure if any, due to such a step would be recoverable from the unpaid bills/security deposit of the Tenderer. This is apart from any penal measure the undersigned may take steps including Black Listing of the contractors and forfeiture of Earnest Money.

16 (A) A penalty @ of 1 % (One Percentage) of the value of work may be imposed on per day of delay.

16 (B) If during execution of work it is found that the progress of work is very slow & the contractor failed to speed up the work even after repeated reminders and the work is going to be delayed unnecessarily due to fault on the part of the contractor and/or the quality of work is not as per the schedule and the contractor does not make require rectification after being so instructed, the work order and contract shall be cancelled, the earnest shall be forfeited, the contractor may be Black Listed and the claim of payment work already executed before such termination, may not be considered or entertained.

16 (C) In case of such mid term termination of the work order and contract, the undersigned may also proceed to get the balance work completed by engaging other contractor or departmentally. The excess expenditure if any due to such a step would be recoverable from the unpaid bills of the defaulting contractors, if claim of such bill has not been forfeited at the time of termination work order and contract as mentioned at point be above.

17 The agency must submit following test report of materials sample collected from the site before execution of work. (A) Compressive strength of cement (B) Grading of Sand (D) Crushing strength of stone chips

18 Fixing of Informatory Signboard & taking of Photographs at the own cost & effort of the successful Tenderer (Contractor) are precondition of this Tender. This end will make no extra payment to these effects to the Contractors

19 The Supplier should fix the Informatory Signboard at a visible point at the site of work before commencement of the work as per instruction of the undersigned.

20 The Contractor should take photographs of the work in three phases. First, before commencement of the work by affixing Signatory board, Second during execution of the work and finally, after completion of the work at his own cost & effort and submit all the photographs to this office periodically.

21 The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.

22 *** Work order will be issued to the successful bidders after availability of mentioned fund as per decision finalized by the Artho o Parikalpana Upasamity.
