- Bidders must upload self-attested photocopies of valid GST registration Certificate with Current Return, last three years Income Tax Return with PAN Card (Assessment Year 2020-21, 2021-22 and 2022-23), Profession Tax Registration Certificate with current challan(2023-24) and Trade Registration Certificate/License(2023-24)
