





Annexure-B

Terms & Conditions :-

1. Bidders must upload self-attested photocopies of valid GST registration Certificate with Current Return, last three years Income Tax Return with PAN Card (Assessment Year 2020-21, 2021-22 and 2022-23), Profession Tax Registration Certificate with current challan(2023-24) and Trade Registration Certificate/License(2023-24).
2. Bidders must submit Credential in similar nature of work inbetween the last three financial years (i.e 2020-21, 2021-22 and 2022-23).
3. In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
4. The bidders will have to show or submit original testimonials after the opening technical bid if asked by the tender inviting authority.
5. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
6. No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders.
7. **Participation Charge and EMD:: For all bidders required to make payment of Participation Charge in cash mode to collect the GP Motfarakka, a scanned copy of which shall have to upload with other necessary documents and EMD as mentioned above should be paid through direct deposit method only to Bank AC no 5140011001480, BGVB Dalimga Branch IFSC CODE - PUNB0RRBBGB. The receipt voucher of Participation Charge and EMD shall have to upload along with other necessary documents.**
8. Successful Bidder (s) will have to lodge security deposit (10% of the total value of the work as quoted by him) deducted from every running payment (not exceeding three including the Final bill) made and will be released after 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other
9. GST, ITDS and Labour Cess will be deducted as per existing rates fixed by the respective department of the Government.
10. Site visit may be done by the bidders at their own cost.
11. Erroneous or incomplete e-Tender will be summarily rejected without assigning any reason whatsoever.
12. Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
13. Quoted rate shall be inclusive of all charges including royalty, GST, tools charges, transportation etc.
14. Register Partnership Deed in case of partnership firm has to be submitted. The company shall furnish the Article of Association and Memorandum. Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall where uploading any tender for on behalf of the company or firm invariably upload a copy of register power of attorney showing clear authorisation in his favour, by the rest of the director of such company or the partner of such firm to upload such tender. (non statutory
15. Joint venture will not be allowed.
16. Payment will be made as and when fund is available from the concerned source. No claim for whatsoever for R.A. Bill payment. Only final Bill will be paid for this work. Contractors are requested to quote their rate accordingly.
17. During scrutiny if it comes to notice of the tender inviting authority that the credential or any other paper found incorrect/ manufactured/ fabricated, that bidder would not be allowed to participate in the tender and the application will be rejected without any prejudice.
18. The contractor's responsibility to keep the road open to all kind of traffic during the execution of work. No claim whatsoever will be entertained for idle labour, establishment cost of hire and labour charges of tools and plants and any unwanted incidence etc. at any circumstances.
19. Time is the essence of contract. The successful contractors must start the work within seven days from the date of signing of agreement/ contract failing of which the undersigned may cancelled the work order and contract and forfeit the earnest money. The work should be completed within the prescribed time. No extension of time will be allowed in special cases if it is found that the delay caused due to such reason which is beyond the control of the contractor and on the issue whether any reason is beyond the control of the contractor, the decision of the undersigned shall be final.
20. A penalty @ of 1% (One percent) of the value of the work may be imposed on per day of delay.
21. If during execution of work it is found that the progress of work is very slow and the contractor is failed to speed up the work even after repeated reminders and the work is going to be delayed unnecessarily due to fault on the part of the contractor and/ or the quality of work is not as per the plan and estimate and the contractor does not make required rectification after being so instructed, the work order and contract shall be cancelled, the earnest money shall be forfeited, the contractor may be black listed and claim of payment of work already executed before such termination, may not be considered or entertained.
22. In case of such mid-term termination of the work order and contract at, the undersigned may also proceed to get the balance work completed by engaging other contractors /agencies or departmentally. The excess expenditure if any, due to such a step would be recoverable from the unpaid bills of the defaulting contractor, if claim of such bills has not been forfeited at the time of termination of work order and contract as mentioned at point be above.
23. Bidder(s) may be asked to submit rate analysis for items where the quoted rate are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the bidder have formed a cartel and rates have been manipulated, unbalanced or unreasonable.
24. Agency submit test report of materials if required:- A) Compressive strength of cement B) Grading of sand (sieveanalysis), C) Crushing strength of stone
25. **The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be done without assigning any reason whatsoever.**
26. Contractor should maintain Covid-19 precaution (Social distance mask sanitizer etc.) at work place as per govt norms and no claim will be entertained for such type of expenditure incurred by the contractor.
27. **Work order will be issued as and when fund is available from the concerned source. No claim for whatsoever for R.A. Bill payment. Only final Bill will be paid for this work. Contractors are requested to quote their rate accordingly.**
28. **The undersigned holds the authority to cancel the whole tender without assigning any reason.**


