per A above and considering all addenda and corrigendum. Both Technical bid and Financial Bid are to be submitted concurrently duly signed digitally in the website <http://etender.wb.nic.in>

C. EARNEST MONEY DEPOSIT

As per G.O. No. 416(8)-W(C)/1M-291/16 dated 03-08-2016 of the Joint Secretary, Works Branch, PWD in concurrence to G.O. No. 3975-F(Y) dated 28-07-2016 of the Secretary, Audit Branch, Finance Department a bidder should initiate payment of pre-defined **EMD** for the tender by selecting from either of the following payments modes:

i) Net Banking (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI Bank Payment Gateway;

ii) RTGS/NEFT in case of offline payment through bank account in any Bank.

Tender document may be download from website & submission of Technical Bid/Financial Bid as per Tender time schedule stated in **(Date & Time Schedule)**.

The documents submitted by the bidders should be indexed and also should be according to his / their

Firm name.

D. ELIGIBILITY CRITERIA

The tenderer should have experience in similar type of work. At least 60% credential of 1 (One) such works in last 3 years is required. Self Attested documents are to be submitted, only in the form of completion Certificate .

E. DEFINITION OF CREDENTIAL

i)Payment certificate will not be treated as credential.

ii)Credential certificate issued by the Executive Engineer, or equivalent competent authority of a state Central Government, State/ Central Government undertaking, statutory /Autonomous bodies Constituted under the Central/ Statute, on the execute value of completed running work will be taken as credential. (vide Notification No. 03-A/PW/O/10C-02/14 , Dated: 12.03.2015 of Principle Secretary to the Govt. of W.B, P.W.D

No credential may be considered as valid unless it is supported by payment certificate, work order, price Schedule or BOQ of work and completion certificate/work progress certificate, mentioning the date of completion certificate should indicate the value of the work (equal to booked expenditure) [Non Statutory Documents].

N.B.: Estimated Amount, Date of completion of project detail, address for communication of Client must be indicated in the Credential Certificate.

F. TERMS AND CONDITIONS

1) For registered Unemployed Engineers' Co-operative Societies / Unemployed Labour Co. - Op. Societies are required to furnish valid Bye Law or societies along with the article of Association and Memorandum, Current Audit Report along with certificate of registration issued by Govt. of W.B Co- opp. Directorate of the concern dist. Of govt. of W.B., Minutes of last A.G.M. [Non Statutory Documents]

2) Registered partnership deed For partnership Firm only) along with power of attorney to sign on the tender document (If required). The limited company shall furnish A) Certificate of incorporation under company act. B) Valid trade license , C) Memorandum and Article of Association , D) Registered power of attorney as per Registration act 1908.

- 3) Joint venture will not be allowed.
- 4) A prospective bidder participating in a single job either individually or as a partner of a firm shall not be allowed to participate in the same job in any other form.
- 5) A prospective bidder shall be allowed to participate in a single job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job, all his application will be rejected for that job,
- 6) "Any intending bidders who have failed to execute more than one works contract under any Directorate of this Department and was terminated by any sub rule under clause 3 of Tender Form No 2911 or terminated under any clause of Standard Bidding Document by the Engineer-in-charge / Employer 'during last 3(Three) years will not be eligible to participate in any bid under any Directorate under this Department for another 2(Two) years from the date of imposition of last termination notice by the Engineer-in-charge Employer.
- 7) Additional Performance Security: The Additional Performance Security @ 10% of the Tender amount shall be obtained from the successful bidder, if the accepted bid value is 20% or more than 20% less than the estimated amount put to tender. (Ref: No- 1T-06/2017/444-R/PL dt. 18/04/2017 & Corr. No.1T-06/2017/936-R/PL dt. 23/08/2017 of the Pr Sec., PWD).
- 8) Constructional Labour Welfare Cess 1 (one) % of cost of construction will be deducted from every Bill of the selected agency. GST, Royalty & all other statutory levy/ Cess will have to be borne by the contractor & the rate in the schedule of rates inclusive of all the taxes & cess stated above.
- 9) No Mobilization Advance and Secured advance will be allowed. Agencies shall have to arrange equivalent land for installation of Plant & Machineries, (specified for each awarded work, storing of material, labour shed, laboratory etc. at their own cost and responsibility.
- 10) No price preference will be allowed for the work under this NIT (ref fin no- 8648-F(Y), dt: 12.10.12)
- 11) BID shall remain valid for a period not less than 120 days (One Hundred Twenty Days) from date of opening of the financial proposal. However, extension of bid validity may be suitably considered by the Tender Inviting Authority, if required, subject to obtaining a written confirmation of the contractor/bidder(s) to that effect. If the Bidder withdraws the Bid during the period of Bid validity his Earnest Money Deposit will be forfeited.
- 12) All materials like Cement, steel, Stone etc. will be supplied by the Contractor .
- 13) The Bidder. at the Bidder's own responsibility and risk is encouraged to visit and examine the site of works and its Surroundings and obtain all information that may be necessary for preparing the bid and entering into a contract for the work as mentioned in the Notice inviting Tender, the cost of visiting the site shall be at the Bidder's own expense. Traffic management and execution shall be the responsibility of the Agency at his/her/their risk and cost.
- 14) Payment of bill will be made according to availability of fund and mode and procedure of payment will be as per Govt. Rules / Govt. Orders.
- 15) Penalty for delays. The Contractor shall ensure that the services are performed in accordance with the specifications and within the stipulated time frame. Performance of duties and obligations under the Contract not completed within the stipulated period for completion will attract a penalty of one percent (1%) of the Contract Price being deducted per day, for each day of delayed performance and six percent (6%) of the Contract Price being deducted per day, for each day of delayed performance in cases of Scrap sale/delivery agreements.

16) If any contractor fails to start the work within 7 (Seven) days from issuing date of work order/ Formal Tender the Work Order will be treated as cancelled and relevant clauses of the contract shall be deemed to have been executed by the tendering authority. No litigation to this effect shall be entertained by the tendering authority, this is incorporated to deliver time bound Public Works.

17) The lowest bidder (L1) shall submit the Hard copy of the Technical Bid & Financial Bid in Original to the Pradhan, Rampur Gram Panchayat as given in Table above (page-1). Failure to submit the hard copy with the acceptance letter within the time period prescribed for the purpose, may be construed as an attempt to disturb the tendering process and will be dealt with accordingly including blacklisting of the bidder {Ref : Notification No.-2254-F(Y) dt 24/04/2014 of The Pr. Sec. Finance Deptt and No-547-W©/1M-387/15 dated 16/11/2015 of the Jt Sec, PWD}

G. INSTRUCTION TO BIDDERS

1. General guideline for e-Tendering:

Instructions/ Guidelines for tenders for electronic submission of the tenders online have been annexed for assisting the contractors to participate in e-Tendering.

2. Registration of Contractor:

Any contractor willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement system ; through logging on to <http://wbtenders.gov.in> the contractor is to click on the link for e-Tendering site as given on the web portal.

3. Digital Signature certificate (DSC):

Each contractor is required to obtain a class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders, from the approved service provider of the National Information Centre (NIC) on payment of requisite amount details are available at the Web Site stated in Clause 2 of Guideline to tender participant DSI is given as a USB e-Token.

4. Downloading of Tender Documents The contractor can search & download NIT & Tender Documents electronically from computer once he logs on to the website mentioned in Clause 2 using the Digital Signature Certificate. This is the only mode of collection of Tender Document.

5. Submission of Tenders :

General process of submission, Tenders are to be submitted through on time to the website stated in C 1. 2 in two folders at a time for each work, one in Technical Proposal & the other is Financial Proposal before the prescribed date & time using the Digital Signature Certificate (DSC) the documents are to be uploaded virus scanned copy duly Digitally Signed. The documents will get encrypted (transferred into non readable formats).

6. Penalty for suppression / distortion of facts:

If any tender participant fails to produce the original hard copies of the documents (especially Completion Certificate and audited balance sheets), or any other documents on demand of the Tender Evaluation Committee within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies or if there is any suppression, the tender participant

shall be suspended from participating in the tenders on e-Tender platform for a 3 (three) years. In addition, his user ID will be deactivated and Earnest money deposit will stand forfeited. Beside, the Authority may take appropriate legal action against such defaulting tender participant as per I.T. Rule.

7. Rejection of bid :The Prodhana reserves the right to accept or reject any Bids/Tender and to cancel the Bidding processes and reject all Bids /Tender at any time prior to the award of Contract without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected bidder or Bidders of the ground for such action from tender inviting authority.. The declaration by the bidder must be affidavit on a Non Judicial Stamp paper of Rs. 10/- only. Machinery or equipment ownership proof documents (Chaffan / registration certificate) must be submitted along latest calibration or fitness certificate from competent authority. In case of ledger deed, tender reference no. must be mentioned and original documents of machineries must be physically verified at said office before technical evaluation, otherwise treated as invalid. Maximum age of all machineries not exceed 5 years from the date of NIT.

8.Award Of Contract.

The Bidder whose Bid has been accepted will be notified by the Tender Inviting & Accepting Authority. The notification of award will constitute the formation of the Contract. The Agreement in W.B.F.No.-2911/2911(i)/2911(ii) with incorporation of all the required documents, i.e., NIT including all its agenda & corrigenda, Section-A, Section- B, Section-C and Financial Offer on Bill Of Quantities (BOQ) will be executed between the Tender Accepting Authority and the successful Bidder.

N.B.: The Bidder whose Bid has been accepted will be notified by the Tender inviting & Accepting Authority acceptance letter / Letter of Acceptance. The letter of Acceptance will constitute the formation of the Contract.

9. There shall be no provision of Arbitration.

10. Defect Liability Period: (As per Order No. 5784-PW/L&A/2M-175/2017, Dated: 12.09.2017) Construction of new building / new bridge / new culvert, construction of building / bridge / culvert including construction of approach roads for bridge / culvert, Construction of rigid pavement, Reconstruction of rigid pavement, Construction of new flexible pavement covered by mastic work which has been designed for a period of 5 years or more, Widening and strengthening of flexible pavement covered by mastic work which has been designed for a period of 5 years or more, Improvement of riding quality / Strengthening of flexible pavement covered by mastic work which has been designed for a period of 5 years or more, the Defect Liability Period of the work shall be five years from the actual date of Completion of the work;

(d)For work with five years Defect Liability Period: (I) No security deposit shall be refunded to the contractor for 1ST 3 years from the actual date of completion of the work;

(II) 30% of the security deposit shall be refunded to the contractor on expiry of four years from the actual date of completion of the work.

(III) The balance 70% of the security deposit shall be refunded to the contractor on expiry of five years from the actual date of completion of the work,

11) **BID CAPACITY:** The available Bid Capacity at the expected time of bidding (to be calculated on the basis of prescribed format vide Form-IIA of the prospective applicant shall not be less than the Estimated amount put to tender of intended job. Form – III A in this respect is to be duly submitted along with uploaded Document.

12) If any discrepancy arises between two similar clauses on different notifications, the clause as stated in later notification will supersede former one in following sequence:

- i) Form No. 2911
- ii) NIT
- iii) Special terms & Condition
- iv) Technical bid
- v) Financial bid

13) Qualification Criteria: The Tender Inviting and Accepting Authority will determine the eligibility of each bidder shall have to meet all the minimum criteria regarding: -

- a) Financial Capacity
- b) Technical Capability comprising of personnel & equipment capability
- c) Experience / Credential.

H) SPECIAL TERMS & CONDITIONS :

a) Job Card holders shall be mandatorily be engaged in the Departmental works where rural unskilled workers can be engaged. Contractor are liable to deposit Karmashree related Form & Anexture Vide memo no-No.1140PRD-33011/1/2024-MGNREGASEC ,Date: 07.03.2024 .

b) The contractor / agency executing the work shall also furnish a certificate after completion of work that only Job Card holders were engaged for unskilled works during execution. The certificate shall be countersigned by the Departmental official directly supervising the work. Scrutiny of such certificate will be done by departmental officials before making payment against works.

C) Work order will be issued after receiving the fund installation. Those who complete the work first will get paid first. If someone neglects to work, his work order will be cancelled. The EMD will be retained till the work is completed.
