7. Any failure to maintain the above condition, the vehicle will be discharged from this office without any further correspondence.
8. In case any illegality is found occurred by the driver /owner involving the said hire vehicle, the vehicle shall be immediately released by the undersigned.

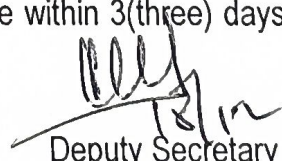

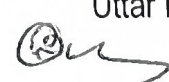
The selected person(s) / agencies will have to place the hired vehicle within 3(three) days from the date of issue of order.
