Delayed submission of tender documents shall lead to outright rejection. The undersigned will not be responsible for rejection of the tender due to the delay in the postal/courier transit or any other reason. The Sealed Tenders will be opened on the same day i.e. on 24/01/2020 3 PM in presence of the bidder who may wish to remain present. Tender Form along with relevant documents has to be purchased from the Gram Panchayat office.

Original certificates or documents as specified in Annexure-B (No. 2&3) must be produced on demand at any stage of tender procedure. All applicable Tax and Labour Cost as per Govt. Norms.

Annexure-B
Terms & Conditions :-


- Cost of Tender Form (non-refundable) has to be paid in cash only.
- Bidders must submit attested photocopies of valid GST registration Certificate (if any), last three years Income Tax Returns, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be.
- Bidders must submit Certificate in similar nature of work during last three years.
- In case of bidder tender emanating from categorization of bidders, entire tender process will be cancelled.
- Bidders must quote rates in absolute numerical values (both in figures and words) and percentage against the estimated cost.
- Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
- No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidder.
- Bidder must submit sealed envelope clearly mentioning serial number and name of work on top of the envelope.
- Earnest money should be deposited in Cash/Cheque/Bank Draft or Government Bond Securities duly pledged in favour of the Pradhan, Anantapur Gram Panchayat and will be refunded/forfeited as the case may be. In case of cash/cheque/bank draft, the bidder must collect money receipt from Gram Panchayat office and quote the number in tender form. In case of Government Bond securities respective pledged documents need to be submitted along with Sealed Tender.
- Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of Cash/Cheque/Bank Draft/Government Bond / Securities duly pledged in favour of the Pradhan, Anantapur Gram Panchayat or the amount may be deducted from every running payment just exceeding three including the final bill) made and will be released 6 months in case of Building, Culvert and Concrete Bids and 3 months in all other cases.
- STDS/GST, ITDS and Labour Cost will be deducted as per existing rates fixed by the respective departments of the government.
- Pre-bid conference/meeting with the prospective Bidders will be held on 24/01/2020 3 PM (not later than 4 days before the last date of submission of Tender). Environmental and Social Safeguards issues pertaining to the tendered work will also be discussed and explained in the meeting.
- Site visit may be done by the bidders at their own cost.

15. Extension or incomplete Tender Party will be summarily rejected without assigning any reason whatsoever.
16. Bidders may be asked to submit site analysis for roads where the quoted rates are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, withdrawal of responsibility.
17. Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Grant terms shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
18. The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.
19. Quoted rates shall be inclusive of all charges including royalty, GST, bank charges, transportation, etc.
20. Any bid received from the bidder without authentication of correctness made in ink printed in word or figure shall lead to cancellation of the bid.
21. Bidders will get necessary drawings with the Tender Form. All documents i.e. drawings Tender Form signed by the Bidder must be submitted in Green Tender addressed to Pradhan, Anantapur Gram Panchayat, V/O - Madalar, P.O - Madalar, Taluk - Uttar Dinajpur.
22. The quoted rates shall be inclusive / exclusive of GST and Labour Cost but exclusive of all other taxes including any Cess, surcharge, Levy or tax by whatever name called imposed under GST law or any other law at any time GST at the applicable rates shall be payable there.
23. Tenderer shall estimate the various provisions of CGST Act and Rules (up to date amendments) and other applicable taxes before bidding.
24. The contractor shall submit the invoice of the work executed as per rate. The taxes will be calculated as per rules.
25. ITDS, GST, TDS, labour cost and other statutory deductions shall be made at source as per prevalent laws.
