Instructions for submission of Quotations / Tender:

The Tender / Quotation for the consolidated work will be governed by the following terms & conditions :-

1. Cost of Tender Form (non-refundable) has to be paid in cash only. **The rate should be quoted in % (percentage) basis on the total Estimate value** of the work i.e. at per/ above /less both in figure and words other wise the tender will be treated as informal. Work must be executed according to the departmental schedule as per direction
2. Tender Form(s) are to be collected from the Panchayat Office by Rasakhowa-I G.P. applying to authority in your own pad, It must be signed by full name & with rubber stamp. At the time of submission of quotation in own pad, The prospective bidders shall have past credentials(payment)certificate 60% (Sixty percent) of the Estimate amount under authority of state/Central govt, Central/State Government undertaking/Statutory Bodies.
3. The undersigned is not be bound to issue Tender Forms to all the applicants. Decision of the undersigned regarding issue of Tender Form is final. Only one Tender Form will be issued to a proprietor for one item. Form value is not refundable.
4. No consumable materials will be supplied to the agency for any work from the office of the undersigned. Agency will be responsible for procuring all materials required for proper executing of work at his own cost.
5. All rates shall be inclusive of all charges, royalty, toll charge, carriage etc.
6. If the last date of submission of Tender is declared as holiday the Tender will be received up to next dt. Hrs. & will be opened as usual.
7. At the time of your form(s) submission, Bidders must submit attested self photocopies of valid VAT registration Certificate (if any), last three years Income Tax Return, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be and also the Earnest Money by Bank draft/NSC/DCR of the above mentioned amount in favors of "Pradhan, Rasakhowa-I Gram Panchayat".
8. Quotations/ Tenders must be filled in English. Quotation is to be submitted in sealed cover, no time extension.
9. Quotations / Tenders should be submitted using the original Quotation / Tender form issued for the purpose. All pages of the filled in Quotation / Tender formats are to be signed by the authorized signatory of the firm submitting the Quotation / Tender.
10. Site visit may be done by the bidders at their own cost.
11. Earnest money should be deposited in Cash/Cheque/Bank Draft or Government Bond/Securities duly pledged in favour of the Pradhan, of Rasakhowa-1no Gram Panchayat and will be refunded/forfeited as the case may be. In case of Cash/cheque/bank draft, the bidder must collect receipt from Gram Panchayat office and quote the Number in Tender Form. In case of Government Bond/securities respective pledged documents need to be submitted along-with Sealed Tender.
12. Earnest money noted against the work @2% of the value of the work will have to be deposited. The earnest money will be converted into security money after acceptance. Balance 8% security money will be deducted from the bill to constitute 10% security money. The security money will be released as per norms. Engineer's Co-operative securities will not be required to deposit any earnest money.
13. Bidder must submit sealed envelope clearly mentioning serial number and name of work on top of the envelop.
14. Rasakhowa-I Gram Pancahyat also the name of the scheme should be super scribed on the envelop . The name and address of the firm/ Contractor submitting the Quotation / Tender must be written at the lower left corner of the cover envelope including contract reference no. of the tenderer / firm


5. Payments shall may be made only against "Running Account bill" in one parts, 1st Running Account bill and final account bill through account payee cheque within 10 days of submission of bill.

6. Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed cartel and rates have been manipulated, unbalanced or unreasonable.

7. work will be covered for defects and liability for a period of 6 (Six) months from the date of completion.

8. Before starting the work the work site must be dressed and cleaned by cutting the sorts of jungle shrubs etc. for which no extra payment will be made. Site visit may be done by the bidders at their own cost.

9. Successful tenderers will have to complete the work and installation within 30(Therty) days from the date of receipt of the work order. As directed by The Pradhan.


