The undersigned will not be responsible for rejection of the tender due to the delay in the postal /Courier transit or any other reason. The sealed Tender will be opened on the same day at 3.00 pm in presence of bidders, who may wish to remain present. Tender from along with reinvent documents has to be purchased from the Gram Panchayat Office.

#### Annexure -B

#### Terms and Conditions:-

- 70. Cost of Tender Form (non-refundable) has to be paid in Cash only.
- 71. Bidders must submit attested photocopied of valid VAT registration Certificate (if any), last three years income tax return profession Tax registration certificate with current challan and Tread Registration Certificate/License from Local bodies as the case may be.
- 72. Bidders must submit Credential in similar nature of work during last three years.
- 73. In case of bid/Tender emanating from cartelization of bidders, entire tender processed will be cancelled.
- 74. Bidders must quote rates in absolute numerical values (both in figures and words) and percentage against the estimate cost.
- 75. Rate offered by a bidder in a particular tender shall be treated as final and subsequent negotiation with that bidders for change in price shall not be allowed.
- 76. Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
- 77. No special preferences in respect of Earnest Money, Security deposit etc will be given to any Co-oprative sociality / Govt. owned company / Govt. undertaking / Corporation / Engineering Co-oprative etc. in other words, all participating bidders will be treated on equal basis only and no favorable / special considerations will be accorded to any bidders.
- 78. Bidders must submit sealed envelope clearly mentioning serial no. and name of work on top of the envelope.
- 79. Earnest money should be deposited in Cash/ Cheque / Bank Draft or Govt. Bond /Securities duly pledged in favor of the Pradhan, Malgaon Grram Panchayat and will be refund/forfeited as the case may be. In case of Cash /cheque /bank draft, the bidder must collect receipt from Gram Panchyat office of quote the number in tender form. In case of Govt. bond /securities respective pledged documents need to be submitted along with sealed tender.

- 80. Successful bidders (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of cash/cheque /bank draft/ govt. bond/ securities duly pledged in favor of the Pradhan, Malgaon Gram Panchayat or the amount may be deducted from every running payment (not exceeding two including the final bill) made and will be released after three months in all cases excepted ISGPP Block Grant where it will be released after 6 month in case of Building Culvert and Concrete Roads and three months in all other cases.
- 81. STDS, ITDS and Labour Cess will be deducted as per exceeding rates fixed by the respective department of the government.
- 82. Pre-bid conference / meeting with the respective Bidders will be held on \_\_\_\_\_\_ at \_\_\_\_\_ PM (not later than 4 days before the last date of submission of tender). Environmental and Social Safeguards issues pertaining to the tendered work will also be discussed and explained in the meeting.
- 83. Site visit may be done by the bidders at their own cost.
- 84. Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.
- 85. Bidders may be asked to submit rate analysis for item where the quoted rates are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the bidders have formed a cartel and rated have been manipulated, unbalanced or unreasonable.
- 86. Successful bidders will have to execute a formal contact on a non-judicial Stamp Paper with on seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF(Environmental and Social Management Framework) issued shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
- 87. The undersigned is not bound to accept the lowest tender and reserves the right to accepted or reject any or all tender, as the case may be without assigning any reason whatsoever.
- 88. Quoted rate shall be inclusive of all changes including royalty, VAT. Tools charges, transportation etc.
- 89. Any bid received from the bidders without authentication of correction made in rate quoted in word or figure shall lead to cancellation of the bid.
- 90. Bidders will get necessary drawing with the tender form. All documents i.e. drawing tender form signed by the Bidders must submitted in sealed tender addressed to Pradhan, Malgaon Gram Panchayat, Vill & Post: Raghunathpur, P.S- Kaliyaganj, Dist: Uttar Dinajpur
- 91. Penalty charge will be counted if agency does not completed works within the stipulated time.
- 92. Tender amount may be very as per vetted amount.
