The financial proposals of bidders whose technical proposals this process shall be clearly mentioned in the notice inviting tender as mentioned specific dates as below.

1. Quotation should be submitted in their own letter head pad accompanied with prescribed form or in the prescribed format with sl no. in sealed cover. The name of work, Quotation memo no and Serial no, Name and address of the quotationer should be super scribed on the cover.
 - a) 1 No 12 volt 40 WP solar module with 3 years manufacturing warranty
 - b) 1 No 12 volt 14800 mah lion inbuilt solar battery (system certified by BIS) with 30 months manufacturing
 - c) 1 No. 15 Wat LED luminary (system certified by IES, MNRE, LM 80, LM 79, IP65) with automatic photo censer motion sensor (dusk to dawn) including 20 months manufacturing warranty.
 - d) 18 fit height tubular pole 3"- 2.5" dia. made of G.I. pipe with anti corrosive enamel spray painting.
 - e) DC cable (2 mm copper wire) and accessories as per requirement.
2. Rate must be quoted in both figures and words mentioning all tax at his own letterhead pad/plain paper. doubly quoted rate, confusing rate, over written rate will be rejected forthwith. Form value is not refundable.
3. Only one Tender Form/Participation charge will be issued to a proprietor for one serial number. Form value/Participation charge is not refundable.
4. No consumable materials will be supplied to the agency for any work from the office of the undersigned. Agency will be responsible for procuring all materials required for proper executing of work at his own cost.
5. All rates shall be inclusive of all charges, royalty, toll charge, carriage etc. The suppliers will have to deposit EARNEST MONEY of the quoted / tendered amount accompanied with the Quotation/Tender positively failing which the Quotation / Tender will be rejected. Incomplete Quotation/ Tender will be summarily rejected.
6. If the last date of submission of Tender is declared as holiday the Tender will be received up to next dt. Hrs. & will be opened as usual.
7. At the time of your .Quotation own letter head pad submission, Bidders must submit attested self photocopies of valid VAT,GST registration Certificate (if any), last three years Income Tax Return, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be and also the Earnest Money by Bank draft/NSC/DCR of the above mentioned amount in favors of "Pradhan,RASKHOWA-I Gram Panchayat".
8. Quotations/ Tenders must be filled in English. Quotation is to be submitted in sealed cover, no time extention.
9. Quotations / Tenders should be submitted using the original Quotation /OWN Pad/ Tender form issued for the purpose. All pages of the filled in Quotation / Tender formats are to be signed by the authorized signatory of the firm submitting the Quotation / Tender.
10. Earnest money should be deposited in Cash/Cheque/Bank Draft or Government Bond/Securities duly pledged in favour of the Pradhan, of RASKHOWA-1no Gram Panchayat and will be refunded/forfeited as the case may be. In case of Cash/cheque/bank draft, the bidder must collect receipt from Gram Panchayat office and quote the Number in Tender Form. In case of Government Bond/Securities respective pledged documents need to be submitted along-with Sealed Tender.
11. Earnest money noted against the work of the value of the work will have to be deposited. The earnest money will be converted into security money after acceptance.
12. Earnest money noted against the work @2% of the value of the work will have to be deposited. The earnest money will be converted into security money after acceptance. Balance 8% security money will be deducted from the bill to constitute 10% security money. The security money will be released as per norms. Engineer's Co-operative securities will not be required to deposit any earnest money.

13. Acceptance of lowest quotation/tender is not obligatory and the undersigned reserves the right to accept or reject any or all the Quotations/Tenders without assigning any reason whatsoever.

14. The security money @ 10% including earnest money in case of execution of work will be deducted from bill & amount which will be released after 3 years from the completion of the work. Work will be covered for defects and liability for a period of 3 (three) years from the date of completion.

15. Successful tenderers will have to complete the work and installation within 7 (Seven) days from the date of receipt of the work order. As directed by The Pradhan.
