- i) a) Intending tenderers should produce credential of a Same/Similar nature of Work of the minimum value of 60% of the estimated amount put to tender during 3(three) years prior to the date of issue of this tender notice; or,
  - b) Intending tenderers should produce credential of 3 (three) Same/Similar nature of Work of the minimum value of 30% of the estimated amount put to tender during 3(three) years prior to the date of issue of this tender notice; or,
