E. Date of Submission of Tender :-

- Last date of submission of Tender will be on 29-09-2020 up to 02.00 pm.
- The tender must be submitted in sealed cover superscribing the NIT no. name, address of the tender and the tender should be presented in the tender box on the date and within the time stipulated without fail.

F. Date of opening of Tender :-

Tenders so received on 29/09/2020 will be opened on the same day at 03.00 pm. In presence of the available tenders.

G. Special Terms and conditions :-

- 1 The rate should be quoted in percentages both in figures as well as in words.
- 2 Incomplete tender will be rejected summarily. The Successful tenderers will have to execute a formal agreement on a Non-Judicial stamp worth Rs. 10/- within 10 working days from the date of issue of work order.
- 3 Time is the essence of contract. The successful contractor must complete the work within the time specified for the completion. No extension of the time will be allowed except on special cases. If any contractor fails to complete the work within the stipulated time, the work order issued in his favor will be cancelled without assigning any reason therefor. The undersigned may also proceed to get the balance work completed by any other means including through other contractor. The excess expenditure if any due to such a stop would be recoverable from the unpaid bills, security deposit of tenderer. This is apart from any other penal amount the undersigned may like, including bookkeeping of the contractors and forfeiture of earnest money.
- 4 Audit report of last financial year will have to submit in case of Enge, Corp. society and labour co-op societies. The tender forms are to be received by the chairman or secretary or any member of the society having proper power of attorney. No tender form will be handed over to any other. Confidential of similar types of works will have to be produced in case of Enge-co-op and Labour co-op.
- 5 All works have to be done according to specifications and drawings approved by the authority and as per direction of Pradhan of Markur from Panchayat.
- 6 No consumable materials will be supplied to the agency for any work from the office of the undersigned. Agency will be responsible for procuring all materials required for proper execution of work at his own cost.
- 7 Before starting the work the work site must be dressed and cleaned by cutting the weeds of jungle shrubs etc. for which no extra payment will be made.
- 8 Before starting the work the work site must be dressed and cleaned by cutting the weeds of jungle shrubs etc. for which no extra payment will be made.
- 9 The contractors who will not submit tender paper or don't return the same before the date and time of dropping after receiving the same, will not be allowed to participate in two consecutive tenders.
- 10 Appearance of the lowest tender is not obligatory and the undersigned reserves the right to accept / reject any or all the tenders without assigning any reason. What so ever also to split up tendered work to more than one contractor in the interest of the scheme execution.
- 11 This notice shall form part of the terms and conditions of tender and tenderer shall be bound to abide by them.
- 12 All rates shall be inclusive of all charges, royalty, tollcharges, cartage etc.
- 13 The successful tenderer will have to start the work within seven days from the date of issue of work order after execution of formal agreements as per rule and will have to completed the work within the time allowed for completion.
- 14 Arrangement of unemployed Engineers co-op & Labour co-op in any form should not be allowed towards counting of eligibility in participation of tender.
- 15 Before submission of tender the contractor must visit the work site to judge the local condition from all corners and no plea / complain about the site will be entertained afterwards. It will be presumed that the agency offered the tender after reviewing entire position of the worksite.
- 16 All the working tools and plants and implements required for the work are to be arrange and supplied by the successful tenderer at his own cost.
- 17 If the last date of submission of tender is declared as holiday, the tender will be received up to next working day & will be opened immediately afterwards as usual.
- 18 The tender received after the due date and time and any change in quotation after opening the will be not rightly rejected. Markura Gram Panchayat will not be responsible for the loss of tender from or for the delay in the postal transit.
- 19 Fixing of Informatory signboard & taking of photographs in the own cost & effort of the successful tenderer are pre-condition of this tender. This cost will make no extra payment to these effects to the contractors.
- 20 The contractor should fix of Informatory signboard at a visible point at the sight of work before commencement of the works per instruction of the undersigned.
- 21 The contractor should take photograph of the work three phases first before commencement of the work by affixing signatory board/second during execution of the work and finally after completion of the work at his own cost & effort and submit all the photographs to this office periodically.
- 22 In addition to the normal deductions towards taxes, royalties etc. from the bills being paid to the contractors against the work being executed, deduction of additional amount regarding cess @ 1% of the bill value will be made towards the " Building and other construction works welfare cess Act " as per order of the Finance Dept. Govt. of West Bengal.

Successful Bidder will have to execute a formal contract in a Non-Judicial Stamp paper within seven days from the receipt of letter of Acceptance with the Gram Panchayat where the description, specification, quantity, date of completion of work, other mandatory condition and ESMR (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
