1. Cost of Tender Form (non-refundable) has to be paid in Cash only.
2. Bidders must submit attested photocopies of valid GST registration Certificate, last three years Income Tax Return, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be, PAN Card, all xerox Copies must be self attested.
