- Cost of Participation Charge (non-refundable)
- Bidders must upload self-attested photocopies of valid GST registration Certificate, last three years Income Tax Return with PAN Card, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License with current challan from local bodies as the case may be.

- In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled
