Interested agencies may submit quotation and drop the same at Zilla Parishad tender box on or before ~~4/12/20~~ upto 3.00 p.m. and those will be opened on the same day at 4.00 p.m., interested agencies submitting quotations will have to comply with the following terms and conditions strictly.

1. Generator power to be supplied instantly as and when WBSEDCL power became off.
2. Steady and uninterrupted power supply as and when required including those holidays when office will be remain opened.
3. Rate should be quoted on monthly basis separately for the period (i) April to September and (ii) October to March including operator, fuel and all necessary requirements in all respects.
4. Details information's is to be covered in the quotation.
 - i) Capacity of D.G. set (silent) ii) Model of the D.G. set iii) Cooling procedure iv) Smoke to be discharged to a higher level to avoid air pollution.
5. Separate rate to be quoted for (i) New Annex Building (ii) old Building.
6. D.G. set operator should be posted round the clock.
7. Stand by D.G. set (63 KVA & 125 KVA) to be available if any breakdown occurred with AMF panel.
8. Quotation should be dropped in sealed covered only.
9. Photo copy of the up-to-date Trade License, Valid Income Tax, PAN Card, GSTN clearance certificate to be submitted with the quotation (current year).
10. The rate quoted includes all taxes and incidental charges thereto.
11. The power supply should be made within 7 (seven) days from the date of Work Order.
12. The duration of contractual period for instant power supply as and when required is 1 (one) year from the date of Agreement.
13. The place, shed, platform and other accessories for installation of Machineries will be arranged by the agency.
