Failure to execute the contract will lead to automatic cancellation of the bid.
- 18. The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.
- Quoted rate shall be inclusive of all charges including royalty, GST, tools charges, transportation etc.
- Any bid received from the bidder without authentication of correction made in rate quoted in word or figure shall lead to
- cancellation of the bid. Bidders will get necessary drawings with the Tender Form. All documents i.e. drawings Tender Form signed by the Bidder must be submitted in Sealed Tender addressed to Prodhan Bishnupur Gram Panchayat, P.O - Baharail, P.S -Hemtabad, Dist - Uttar Dinajpur
- The quoted rates shall be inclusive / exclusive of GST and Labour Cess but inclusive of all other taxes, including any Cess, surcharge, Levy or tax by whatever name called, imposed under GST law or any other law at any time. GST at the applicable rates shall be payable extra.
- 23. Tenderer shall examine the various provisions of CGST Act and Rules (up to date amendments) and other applicable
- taxes before bidding. The contractor shall submit the invoice of the work executed as per rule. The taxes will be calculated as per rules.
