i)The prospective bidders shall have satisfactorily completed as a prime agency during the last 5 (five) years prior to the date of issue of this Notice at least one work covering major item of works under authority of State/Central Govt. Central/State Government undertaking/Statutory Bodies and having 60 (sixty) percent of the estimated amount put to tender. Estimated amount, Tendered Amount, Actual date of completion of the project detail address for communication must be indicated in the Credential Certificate.

Credential: Scanned copy of work credential issued in favour of the contractor/bidder as detailed below: In case of execution of supplementary/substitute supplementary items having values more than 30% of BOQ, final gross value of bill (without contractual rates) including such supplementary/ substitute supplementary items may be considered to ascertain similarity in nature of work and authenticated copy of such bills may be uploaded, if made available and desired by the bidder.

ii)The prospective bidders shall have in their full time engagement experienced technical personnel, with the sufficient knowledge of PERT/CPM. Participating agnecy should Technical Person the minimum being one Electrical Engineers Diploma holder and one electrical supervisor.
