The intending tenderer shall have to submit valid PAN issued by the IT Deptt., Govt. of India, I/Tax(current), Professional Tax(current), valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act,2017 along with satisfactory completed as a prime agencyof 60% of estimated value during the last 5 (five) years prior to the date of issue of this Notice at least one similar type of work under authority of State / Central Govt., State / Central Government undertaking / Statutory Bodies and reputed any other concern Tax invoice(s) needs to be issued by the supplier for raising clamim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017.

Rate should be quoted in % (Percentage) in respect of project cost. The rate will include all taxes etc.
