The intending tenderer shall have to submit valid PAN issued by the IT Deptt., Govt. of India, I/Tax(current), Professional Tax(current), valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act,2017 along with satisfactory completed as a prime agency of 60% of estimated value during the last 5 (five) years prior to the date of issue of this Notice at least one similar type of work under authority of State / Central Govt., State / Central Government undertaking / Statutory Bodies and reputed any other concern Tax invoice(s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017.

Rate should be quoted in % (Percentage) in respect of project cost. The rate will include all taxes etc.

The tender documents will be opened on 10-Dec-21 at 4.00 P.M in presence of tenderers in the Tender Section of Uttar Dinajpur Zilla Parishad.

All duties, taxes royalties' cess (including 1% cess under W.B. Building and other Construction workers Welfare Cess). Regulation of Employments condition of Service Act, 1996, toll taxes and other levies payable by the contractor under the contract to the State / Central Government for any other cause, shall be included in the rates, prices and total tender price submitted by the tenderer. One percent cess under W.B. Building and other Construction Workers (Regulation of Employments condition of Service) Welfare cess Act, 1996 will be deducted from the bill(s).


