The intending tenderer shall have to submit valid PAN issued by the IT Deptt., Govt. of India, I/Tax(current). Professional Tax(current). valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017 along with satisfactory completed as a prime agency of 60% of the estimated value during the last 5 (five) years prior to the date of issue of this notice under authority of State / Central Govt., State / Central Government undertaking/Statutory Bodies is preferable, Tax invoice(s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017

Earnest money 2% (two percent) on the tender amount in the shape of DD (Demand Draft) / bankers cheque / pay order to be purchased in favour of the Additional Executive Officer, Uttar Dinajpur Zilla Parishad on any Nationalized/ Bank scheduled bank to be submitted along with tender documents in a sealed cover.

Rate should be quoted in % (Percentage) in respect of project cost. The rate will include all taxes etc.
