The Sealed Tenders will be opened on the same day i.e. on 23/06/2022 after 3.00 PM. in presence of the bidders, who may wish to remain present. Tender Form along-with relevant documents has to be purchased from the Gram Panchayat office.

Annexure-B

Terms & Conditions :-

- Cost of Tender Form (non-refundable) has to be paid in cash only.
- Bidders must submit attested photocopies of Pan Card, Trade license, Professional Tax Paid payment Certificate with Challan for the year 2021-22, Valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act,2017 , Three Years (2019-20, 2020-21, 2021-22) Income tax (Verified Copy Only) With Profit & Loss account & Balance Sheet receipt to be accompanied with the Technical Bid document.
- Intending tenderer should have to produced self attested photocopies of credentials as follows:-i) Intending tenderers should produce credentials of a Similar nature of work (PCC Road) of the minimum value of 40% of the estimated amount put to tender during 5(five) years prior to the date of issue of this tender notice; or, ii) Intending tenderers should produce credentials of 2(two) similar nature of work, each of the minimum value of 30% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice; or, iii) Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 80% or more and value of which is not less than desired value at (i) above
- In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- Bidders must quote rates in absolute numerical values (both in figures and words) and percentage against the estimated cost.
- Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.

... preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned
... Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated
... equal basis only and no favourable/special considerations will be accorded to any bidders.
... Bidder must submit sealed envelope clearly mentioning serial number and name of work on top of the envelop.
... Earnest money deposited in Bank Draft /RTGS/Tranfer issue from any Nationalise bank by Branch / CSP duly pledged in favour of

collect receipt from Gram Panchayat office and quote the Number in Tender Form.

11. Successful Bidder (s) will be required to lodge security deposit (10 % of the total value of the work as quoted by him) as performance security in the form of Cash/Cheque/Bank Draft/Government Bond / Securities duly pledged in favour of the Pradhan, Bhatun Gram Panchayat OR the amount may be deducted from every running payment (not exceeding two including the final bill made .

11.a. The DLP (Defects liability Period) period is 5 (Five) years in case New Building/Rigid Pavement/Culvert/Flexible pavement covered by Mastic work and 30% of the SD shall be refunded after expiry of 4(four) years and rest 70% shall be refunded after expiry of 5(five) years. .

11.b. In case of Flexible Pavement/Extension of Building/Culvert/bridge the DLP period is 3 (three) years and 30% of the SD shall be refunded after expiry of 2(Two) years and rest 70% shall be refunded after expiry of 3(Three) years.

11.c. In case of through Bituminous surfacing repair work less than 40 mm thick./Repair of any road/Building/Culvert/bridge/sanitary & plumbing work the DLP period is 1 (One) years and 100% of the SD shall be refunded after expiry of 1(one) year

11.d. In case of patch repair or patch maintenance DLP period is 3(three) months from date completion of work and 100% of the SD shall be refunded after expiry of 3(Three) months .

12. STDS, ITDS and Labour Cess, GST will be deducted as per existing rates fixed by the respective department of the government.

13. Site visit may be done by the bidders at their own cost.

14. Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.

15. Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.

16. Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.

17. Acceptance of lowest Tender is not obligatory and the undersigned reserves the right to accept or reject any or all the Tender without assigning any reason whatsoever.

18. Tender rate shall be inclusive of all charges including royalty, GST, tools charges, transportation etc.

19. Any bid received from the bidder without authentication of correction made in rate quoted in word or figure shall lead to cancellation of the bid.

20. Bidders will get necessary drawings with the Tender Form. All documents i.e. drawings Tender Form signed by the Bidder must be submitted in Sealed Tender addressed to Pradhan, Bhatun Gram Panchayat, Vill- Bhatol Hat , P.O- Bhatol Hat , PS. Raiganj, District-Uttar Dinajpur

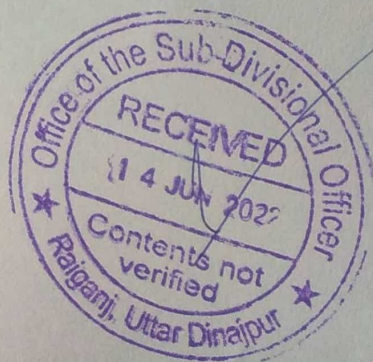
