
1. Last date and time for receiving Application: - Within 16.9.2022 up to 14.00 hours.
2. Last date and time for issue of tender form: - On 19.9.2022 up to 17.00 hours.
[Tender form will be issued to the successful bidders]
3. Date and time of dropping or submission tender form:-On 22.9.2022 up to 14.00 hours.
[Tender form will be received from this end in tender box in schedule time].
4. Date and time for opening of tender form:-On 22.9.2022 at 16.00 Hours.
{The intending bidders or their authorized representative may remain present at the time of opening}

Terms & Conditions:

1. At the time of application ,the tenderer must have to Submit valid and upto date self attested (i) Trade License (ii) Pan Card (iii) GST registration Certificate with current Challan (iv) IT return Acknowledgement for the year 2021-22 (v) Profession Tax Certificate (PT) (vi) Credential [in the form of Payment Certificate/Completion Certificate].
2. The Bidders should have experience in **same/similar** nature of work at least 60 % (Sixty) credential of amount put to tender within 5 (five) years is required.
3. Earnest money noted against the work @2% of the value of the work put to tender in form of DCR/Bank Demand Draft/ Bank Cheque is to be submitted both Engineers Co-Operative and Labour Co-operative Societies in favour of the " Executive Officer, Karandighi Panchayat Samity" .
4. Audit report of last financial year will have to submit in case of Engineer's & Labour Co-Operative Soceties.
5. If required, the undersigned can verify the attached documents with the originals and the tenderer will be bound to produce the originals on being asked failing which the application of tender forms will be cancelled.
6. Time is the big essence of contract. The successful contractor must complete the work within the time specified for the completion. No extension of time will be allowed except on special case. If any contractor fails to complete the work within the specified time, the work order issued in his favour may be cancelled without assigning any reason thereof. The undersigned may also proceed to get the balance work completed by any other means including through other contractors. The excess expenditure if any, due to such a step would be recoverable from the unpaid bills/ security deposit of the contractor. This is apart from any other penal measure the undersigned may take steps including blacklisting of the contractors and forfeiture of earnest money.
7. Participation charge/cost of tender paper [Non refundable] should be remitted through MATFARAKKA from the Office of the undersigned.
8. The rate should be quoted percentage (%) basis both in figures as well as in words in tender form.
9. Incomplete tender form will be rejected summarily. The successful tenderers will have to execute a formal agreement on a Non-Judicial stamp worth Rs. 10/ within 7(seven) days from the issue of work order.
10. All works have to be done according to schedule and specification and as per drawing approved by the authority and as per direction of the Executive Officer, Karandighi Panchayat Samity, and Uttar Dinajpur.
11. No consumable materials will be supplied to the agency for any work from the office of the undersigned.
Agency will be responsible for procuring all materials required for proper execution of work at his own cost.
12. Acceptance of the lowest tender is not obligatory and the undersigned reserves the right to accept or reject any or all the tenders without assigning any reason what so ever.
13. This notice shall form the part of terms and conditions of tenderes and tenderer shall be bound to abide by them.
14. All rates shall be inclusive of all charges, royalty, toll charges, carriage etc.
15. The successful tenderer will have to start the work within 7(seven) days from the date of issue of work order after execution of formal agreement as per rule and will

have to complete the work within the time allowed for completion if failed to do so penalty or termination of work contract may be taken by the tender inviting authority at any stage of work.

16. Before submission of the tender the contractor must visit the work site to judge the local condition from all corners and the estimate prepared for the respective work and no complains/plea about the site will be entertained afterwards. It will be presumed that the agency offered the tender after reviewing entire position of the work site.
17. All the working tools & plants and implements required for the work are to be arranged and supplied by the successful tenderer at his own cost.
18. If the last date of submission of tender is declared as holiday, the tender will be received upto next date & hours and will be opened immediately afterwards as usual.
19. The tender received after the due date and time and any change in quotation after opening the tender will be out rightly rejected.
20. Cess for the welfare of construction workers @ 1% will be deducted at source from the bill amount.
21. The undersigned reserves the right to impose penalty and take legal action against the lowest tenderer. If he is unwilling to undertake the work as per his offered rate.
22. Contractors will have to keep close liason with the office of the undersigned & execute the works as per instruction and the concerned Engineer-in-Charge, who must be kept informed about each step of the work by the contractor.
23. As per order of Dristict Magistrate, Uttar Dinajpur vide order no: - order no- 114/MA&ME dated-03.02.2016 following deduction from bill amount was considered as just a proper to impose Penalty for the delay in completing the respective work. up to 06 months- @1%, up to 6 month to 01 year- @2%, above one year to two years- @ 4%, above two years to three years: - @6%.
24. The Notice Inviting Authority ie. The Executive Officer, Karandighi Panchayat Samity Uttar Dinajpur verify the documents submitted by the bidders in technical verification.. After scrutiny if it is found that the documents submitted by any tenderer is/are either manufactured or false or failing of submitting original papers on a particular date, his bid will be treated as cancelled & black listed from this office up to 3 years.
25. Before issuance of work order, the tender inviting authority may verify submitted documents in original of the lowest bidder or all bidders, After verification if it is found that the submitted documents is either manufactured or false in that case work order will not issued under any circumstances. Legal action also been taken against the bidder.
26. Dispute settlement: - In the event of any dispute by and between the Executive Officer, Karandighi Panchayat Samity and the tenderer, the decision of the Executive Officer, Karandighi Panchayat Samity shall be final.
27. Actual defects liability period for release of security deposited money of the work 3(three) years from the date of competition.
28. The **Undersigned** reserves the right to cancel the NIT or change or modify the date & time schedule of NIT at any time; no claiming in this respect will be entertained.


