9.Bidders may bid for any one or more of the works mentioned in the Table above. i)The prospective bidders shall have satisfactorily completed as a prime agency during the last 5 (five) years prior to the date of issue of this Notice at least one similar nature of work under authority of State/Central Govt. Central/State Government undertaking/Statutory Bodies and having 40 (forty) percent of the estimated amount put to tender. Estimated amount, Tendered Amount, Actual date of completion of the project detail address for communication must be indicated in the Credential Certificate.

Credential: Scanned copy of work credential issued in favour of the contractor/bidder as detailed below: In case of execution of supplementary/substitute supplementary items having values more than 30% of BOQ, final gross value of bill (without contractual rates) including such supplementary/ substitute supplementary items may be considered to ascertain similarity in nature of work and authenticated copy of such bills may be uploaded, if made available and desired by the bidder.

ii)The prospective bidders shall have in their full time engagement experienced technical personnel, with the sufficient knowledge of PERT/CPM, the minimum being one Civil Engineering Degree holder and one Civil Engineering Diploma holder (Authenticated documents in respect of qualifications of engagement shall be furnished for Technical Evolution).
